          - 2. We will be able to edit doc and they will repost revised with our suggestions

          - 1. Happened once in a quarter in 2018, but since they haven't responded

  - i. Website
    - 1. FAQs
      - a. Still have to figure out what those are
    - 2. Bios
      - a. Manju wants the same info we have in ig posts in full sentences, has a doc with formatting
    - 3. Digestible policy/legislation stuff (like how magazine does it)
    - 4. Want to have anonymous SVSH blog around January
      - a. Urgency: for resources lists on other websites, want to make sure they have updated version
        - i. Document is static
    - 5. Want digestible, dropdown list of resources
      - a. Specify confidential versus nonconfidential initially
    - 6. Planning meeting for website things
      - a. Should be same day as anonymous blog meeting
      - b. Could get a rough draft in the next few weeks
        - i. Refine preferably over winter break or next quarter
- **c.** Policy Analyst report
  - i. Meeting update
    - 1. Having a person who would communicate more between nonprofit and UCSB boards (liason): Julia nominates herself
    - 2. STESA programs with middle/high schoolers about consent educations
      - a. Would be hard to be involved with UCSB SASA due to legal issues
      - b. Seeing how we could support them through events and funding
      - c. Emily: encouraging volunteers on an educational front
        - i. Training isn't free, could give a stipend to UCSB students to take care of that fee
          - 1. Would help motivate those w/o resources
    - 3. Beginning to review bills that were introduced in 2020 but dropped bc of COVID
      - a. Seeing how legislators will be treating 5 new bills
      - b. Not this year but next year for the next legislative cycle
      - c. Should review bills and get approval from both boards about which are the most important
        - i. Resource: **leginfo.com**

- Shows current or previous bills, their progress, rationales, arguments for/against
- 2. Not intuitive, co-chairs can help
- d. One specific bill discussed in nonprofit meeting =Gender
  Bias bill
  - i. Were supposed to sponsor last year
  - ii. Right before deadline to introduce it, they dropped it, probably would've been with covid anyways.
  - iii. Alia and Vince spent a lot of time on it last year
  - iv. Currently no legal definition for "gender bias"
    - 1. Any bill or law which evokes this phrase has no legal precedence
    - 2. Makes it hard to standardize
