# A.S. Committee & Ex-Officio Reports

Rony, UCSB campus Controllers Office: One of our jobs as controller is to identify inactive accounts, so that their money can be used, on Monday we presented to Finance Board to reallocate Rally Committee, COSWB and COPS funding, because AS unallocated was getting kind of low. There's also a discrepancy between how much BCCs have allocated for honoraria and how much they need. Also the controller is working on drafting a form to keep track of funds that get donated to charity, to make sure that any profit they make is then donated to charity, to check that these charities get those allocations.

# **Executive Director's Report**: Marisela Marquez, Ph.D.

**Marisela Marquez**: I have a few reports to make to put on the record. For the first diversity training that we haven't had a chance to do, Chris and I are working with a nonprofit organization, "Just Communities", and their program manager is available to do the training on April 30th or May 7th, maybe allocate 2 hours to this, please see what time most people are available.

We're currently doing the interviews for our 75 percent time cashier coordinator staff position, as a result of the recommendation of the internal audit and the additional responsibilities since the UCen cashiers office closed, in order to increase our internal controls there. Speaking of which, the internal audit is ready for you to review, in the main office.

The Web Development Team will be tabling near the AS Main Office to work with individual BCCs and individuals on how to use the collective calendar on the main web

page so we can populate the website with information.

We've never really put this next issue before you, but currently AS has a nonprofit status, and in the past the UCen and AS filed a 990 non-profit tax form together until 1999, when the UC Office of the President said that we didn't have to continue filing together, that the university would file for the both of us, and the UCen and AS didn't file for 2000 or after that. The IRS contacted us recently about why we haven't filed the 990 form, and we've been going back and forth with them, and have employed a tax attorney and external auditors, and we're taking a look at having us exempted from ever having to file a non-profit form ever again, because maybe we never needed to file to begin with.

Construction is going to be done in the Main Office, and maybe part of the working session next week you can suggest how to populate the new office space, or leave it for the next council to decide, but your preference would be good to know.

AS is seeing a lot more festivals and closing down of Pardall on behalf of AS, the staff wanted to make sure that Legislative Council knew about some of the liabilities of doing that, since AS has a larger liability than OSL groups would since we can use the university's insurance, so it would be helpful for this council to consider what boundaries you might want to set on that, and maybe add it to the standing policies of AS.

# **Executive Officer Reports**

**President:** Charlie Arreola None.

Internal Vice President, Chris Wendle: I met with the UCen Governance Board, found out there is a lack of participation by students on campus wide committees and administrative committees. Spring Insight was this Saturday, was considered a success because Floatopia didn't start until 2pm, when most of the families had already left. UCen sales are down \$1.75 million, about \$582,000 of that is from the Campus Assessment Tax. Leg Council has about \$1000 left for special projects. I'm planning the Legislative Council banquet, separate from the AS banquet, the funds for that are coming out of my account. The transition meeting is on May 19th, so be sure to get everything done that you want to get done.

External Vice President of Local Affairs, Clay Carlson: The Campus Planning Committee are discussing a new Bioengineering 2 building, for between Noble Hall and the library, it's being privately funded, the only concern is that it puts the bike, pedestrian and vehicle path all at the same point, so there's a potential for accidents. Floatopia went without a hitch, no one charged the beach, the Facebook organizer of the event was arrested for stealing a golf cart, currently shutting down the beaches are how the county is going to handle it. IV Recreation and Parks Board has closed the bridge Anisq' Oyo Park. There's going to be a new Zip Car on Pardall Road. Next Tuesday at 12:30pm IVTU is arguing for tenant's rights. Earth Day is being set up for April 24th in Anisq' Oyo Park by EAB. The Social Host Ordinance is almost dead, we're telling the county that we're tired

of working with this group, they are going to put it forward without taking our comments into consideration. My office is doing fundraising on April 26th for the approved skate park in IV. IV Parks and Rec has approved a kiosk, paid for and maintained by IVCRC. Two major labor unions are trying to dissolve each other, this is going on state wide, Jaret is playing peace keeper. Coastal Fund is holding the Evolution of Man and Bag, trying to get plastic bags banned from IV and the campus. The Census awareness event had a huge amount of publicity, and will get a lot of funding for our county, but since IV is unincorporated, we have to keep bothering the Board of Supervisors in order to get that money to make improvements to IV. Beth is working on Chillivista for May 8th, Pardall will be closed down for that. We're working on preparing the transition for the next EVPLA, with what each of the coordinators has worked on, and we're starting emergency preparedness planning for IV and campus, to easily mobilize student volunteers and teaching of CPR. The UCen approved having multiple electric signs, there will be an oversight committee for what the boards are used for, we have to see how we can get the funding.

**Marisela Marquez**: I wanted to give you our Legal Resource Center updates, here's a chart with a snapshot of the last two years and how many different kinds of legal advice was requested. There are very interesting patterns, shows that credit problems are a very large needed among our students, this might be a way to gauge need among the student body and create more resources to the students. **Beth Goodman**: Working on the kiosk in IV, it's going to be made out of recycled local eucalyptus, with a map of IV, a place to put signs, and a bench. It's very artsy.

**Chloe Stryker**: I'm working with a guy who sold Haiti tanks for philanthropy, he's expanding and talking to the UCen to buy all the tanks and sell them, and donate them to Haiti. The chair of Media Relations is working on a press conference for the money AS is giving to Haiti, may do an official big check thing.

**Stanley Tzankov**: Also working on promoting the history of activism in UCSB, there's a History of IV book, I'm looking into a small event to promote it. Also talking about recording LC meetings, first step would be to get the UCen to mic the room, so we can upload the meetings to the website, maybe have an agenda with the times when that part starts on the recording.

**Chris Wendle**: My recommendation is to push the UCen to have a room designated for multimedia, with a projector on the ceiling, and more power outlets, a microphone, and a web cam, not just for our use, but also for Faculty Legislature.
