#### Announcements

**Sean Liberman, AS Computer Technician**: I get the voter turn out every day, currently more than 23.7% undergraduates have voted, it's probably around 30% already, so the undergraduate elections have been valid for a day. We just sent out an email to remind those who haven't voted yet.

Nick Allen, Environmental Affairs Board Chair: Wanted to announce that EAB's Earth Day is this Saturday, will have live music and vendors.

#### **Public Forum**

**Chris Wendle**: I'll remind everyone, both representatives and the public, to please be respectful when speaking to one another.

**Coastal Fund Vice Chair**: We're updating our bylaws, and I'm here to endorse the changes, which are primarily verbiage, adding additional duties to the vice chair position, and being more precise in terms of our jurisdiction, extending it to include both the coastline and the local watershed, because we have a lot of projects that deal with that area.

**CalPIRG Campus Organizer**: I came here to inform you that we're up for renewal this year, we've been dealing with a lot of issues that affect students for around 35 years. Everything in our contract is the same other than we've added that AS Legislative Council can vote to rise our pledge fee, which is currently at \$5. I've done campaigning at UC Riverside, who's pledge fee is currently \$10, and raising the price doesn't decrease membership. I would also like to support the Human Rights Council becoming an AS Board, we worked with them to raise over \$5,000 for Haiti relief.

**Queer Student Union, Political Chair**: We attended Finance Board this past Monday, and we are not happy with the allocation we received. Finance Board allocated us \$10,000 to help fund the professional performers for our IV Pride event, which is on the last day of Pride Week. We would like to ask Legislative Council to look at the budget we've provided and fund the remaining \$7,656.60 for this event. We think we should receive this money for a few reasons. First, Finance Board discussed QSU in conjunction with Queer Commission's budget, and QCom's budget shouldn't determine whether QSU gets funding. We are not the same group. Secondly, although we requested funds for educational events of Pride Week, Finance Board funded nothing other than the performers for this last event, which shows us that we, the Queer community, are valued only as a source of entertainment. Also, during the year, QCom has had to deal with a greater number of requests for funding, since Finance Board has been directing groups to come to us to find funding, and we've had to fund them. We think that Pride Week is

important because it creates a positive, educational and supportive environment in a time when programming has been cut in Queer and Feminist studies, bigotry has been rising, and the Queer community has been attacked with slurs constantly. I strongly urge you to bring this up in discussion during your meeting. We're in a time crunch because our events begin this weekend, and we need as much help as possible.

**Alexandra Onodera**: During the Finance Board meeting I specifically asked during QSU's presentation what you had priority in funding, and the first thing that they said was on their list was entertainment for the last day.

**QSU Political Chair**: I was part of the group presenting, and we also said that we needed help funding the safety and the location. All the funding went to the program on the last day, and left no funding for the remaining six days of events.

Alexandra Onodera: Would you rather that \$10,000 go to other line items in your budget?

**Speaker**: That would hinder us. We've already promised that money, and without it we couldn't fund the performers.

Alexandra Onodera: So, the bottom line is that you didn't get enough money?

**Speaker**: It was a slap across the face when we were only funded for something that was only for fun.

Adam Goldman: Have you gone to any other sources of funding?

Speaker: Yes, CAB, IVCRC, other small groups.

Adam Goldman: Anywhere outside of AS?

Speaker: Small restaurant fundraisers.

Adam Goldman: I wouldn't say that you haven't been given support, \$10,000 is a fair amount of money.

Alexandra Onodera: Does QCom set aside an amount of money in the budget process for this event?

**Speaker**: Yes, but as I mentioned before a lot of money for that has been taped by other Queer organizations coming to QCom and asking for money because they have gone to Finance Board and turned away, and right now we don't have the resources that we're being asked to cough up. They don't have the same support system that other groups do, they can't go anywhere else for funding, and Finance Board isn't as accessible, especially neither Finance Board or Legislative Council has had diversity training, I don't think most groups feel comfortable coming to you.

Student Lobby Chair: I presented our budget for next year to Finance Board in January, but

when Finance Board asked me about the budget, I've changed it around. Usually the EVPSA funds Student Lobby's lobby conference in Sacramento, but Finance Board asked what we would do if the EVPSA didn't fund it, so I calculated how much it would take to go on that conference, and specifically allocated that amount in our budget and raised travel/conference line item to \$22,000. This increase would only go to SOCSA, since the DC conference funding comes from the EVPSA. I don't know how the EVPSA's budget looks right now. We increased it more than the EVPSA gave us for it this year, so that we can have room to expand.

**MCC Council**: We're trying to get more funding for our event than Finance Board allocated us. We are trying to hold a gathering this Friday for student usergroups for the MCC, those that make up the MCC Council, we didn't any funding for food preparation for workshops some of the groups want to put on, and no funding for the dinner reception. Food is important for this because it brings our communities together, and we'll have the opportunity to share resources and network, so that usergroups can come and understand the diverse communities on campus. Requesting \$400 for food preparation and \$1200 for the dinner reception. It's open to everyone from noon to 9pm on Friday, April 23rd.

**CAB Chair**: Giving my update for the quarter. Next week is National Volunteer Week, organizing events and on-campus activities, Liberty in North Korea is coming next Tuesday. We're also fundraising for Campus Good Times for kids with cancer. Would also like to support the Human Rights Council on behalf of CAB, I hope it gets passed as a new group.

**Pratish Patel, Finance Board Chair**: I'm here to speak about Monday's allocation to QSU. Finance Board never meant to show that it didn't fully support QSU. We have funded queer events in the past. We funded QSU \$10,000, which was more than ten percent of our remaining budget. Queer Committee was allocated \$13,000 for Pride Week in their budget for this year, with a line-by-line itemized budget that QCom submitted last year. If you add together all the money that QSU has received for this event, it goes over the \$13,000 amount that they initially allocated for this event.

**Sammy Maramba-Ferrell**: QCom suggested that the reason they are requesting money now is because they had to tap into their Pride Week budget in order to provide funding to groups that didn't have any other funding.

**Pratish Patel**: We all face that problem. You have to handle the money you have as best as you can. You need to have your priorities straight.

Daniel Gradias: It's QSU that's requesting money, why are you talking about QCom?

**Pratish Patel**: We assumed that because QCom allocated funds specifically for this event, although it's being hosted by QSU, it's a working collaboration, and QCom is fiscally contributing \$13,000, or was supposed to, and combining their money on this event. It's more about funding the entire event than the two different groups, since they are working together.

**Joel Mandujano**: Doesn't Finance Board reprioritize groups by diversity; has that been happening this year?

**Pratish Patel**: The current policy of Finance Board is first come-first served. We do end up giving out more during the beginning of the year than at the year, and when we run out of money and groups are asking for more money then there is able to be allocated, then we take diversity into consideration, but that hasn't happened yet this year.

**Jason Lopez**: Is it legal for BCCs to move the money around in their budget? **Pratish Patel**: If you haven't seen it yet, a lot of AS is supposed to be one way and it's working another way. BCC budget reallocations are supposed to go through Finance Board and then be approved by Legislative Council.

**Jason Lopez**: So QCom was funded a certain amount, and told you exactly where this money is going, and they are accountable for the money going that way.

**Joel Mandujano**: But QCom said that they had groups come whose only source of funding was QCom.

**Pratish Patel**: I want to say that Finance Board's charge is to fund groups, QCom isn't the direct source for funding, it's not correct to say that we send groups away the first time they come to Finance Board, we've funded Queer community groups on campus.

Joel Mandujano: So do you recommend that QSU not do any new events?

**Pratish Patel**: The reason we allocated \$10,000 for IV Pride was because it was a new part of their event, and we believed that they said that was the most important part for them to get funded, since QCom already had a budget allocated for all their original events, we wanted to contribute to a new event that would expand Pride Week. I want to reiterate the fact that Finance Board does not diminish any student group, BCC or Legislative Council, we want to see events happen, and I want to apologize for any miscommunication, if you have any questions feel free to contact me.

**Nico, Human Rights Council**: You'll be voting on the bill to create the Human Rights Board, it's a popular initiative, there are several members of the Council who came to express support.

**Violetta Muselli, EAB Co-chair**: We have a letter, which was signed by 90 of EAB's general members, and ourselves.

To UCSB Legislative Council:

The Associated Students Environmental Affairs Board supports the Human Rights Council (HRC) becoming the Human Rights Board under Associated Students.

The Environmental Affairs Board has enjoyed and benefited tremendously by collaborating as a member of the council, most notably on raising thousands of dollars for Haitian Relief following

the earthquake in January. We were able to come together so effectively and within such a short period of time because the easy access to the members and chairs of the multiple groups on the council. We raised over \$10,000 in one night, and brought more than 600 students together to learn about the issues at hand. This would not have been possible without the communication and coalition-building the HRC made possible.

A council that brings together student leaders from some of the most influential and dedicated groups on the UCSB campus needs to exist as an AS entity. The Human Rights Board would be a completely new and revolutionary creation. It would make collaboration between groups easy and effective and would legitimize the work that the council has orchestrated in the past.

Associated students was created to represent the diverse needs and issues embodied by our student body. Protection of human rights is a universal issue that could be explicitly championed by UCSB's student government. The strength of the Human Rights Council will be magnified by its further legitimization under AS.

The Environmental Affairs Board wholeheartedly supports the establishment of the Human Rights Board as an Associated Students entity. Let us move continue in the spirit of collaboration that has made such a powerful impact this year.

## Executive Director's Report: Marisela Marquez, Ph.D.

**Marisela Marquez**: "Just Communities" is doing the diversity training in the UCen's Lobero Room on May 7th. It would be great to talk with the incoming board about when they would like to have the same training, or maybe have it already planned for them. The AS banquet is planned for May 27th at Loma Paloma from 7-9pm, we're going to try and get an accurate rsvp count this year. We're almost done with the interviews for the cashier's office 75 percent time position. We're creating a new life time achievement award, in honor of Bob Lordon, who will be the first recipient, it won't be a annual award, only one given out to those special few who have made AS an integral part of their life. Also, other awards including the Lorden Award to a graduating senior.

As a non-profit organization, we can lend other non-profits the use of our tax-id number, we have been asked to do that by Just Communities. They are being given \$50,000 from the Latino Achievement Collaboration, but they have to give that money to a non-profit organization, and

Just Communities hasn't gotten that status yet, so I wanted to hold that money for them with no administrative fee. I'll be writing up an MOU to be submitted to you next week. We'd be the fiscal sponsors of that money, but it doesn't affect us in any particular way.

Staff are now off the campus furloughs as of May. It took a lot of work to do that, and it's a done deal as of this month, with the exception of the folks represented by unions.

## Alex Marroquin: Who pays for the maintenance of the MCC?

**Marisela Marquez**: It's paid through the UCen, since the agreement when the student body voted to build the UCen 2, the MCC building, was that the UCen agreed to always staff our maintenance needs, but because of budget cuts they haven't been able to continue that. I offered to pay overtime for them to continue to clean our office, but it's been pretty hit and miss, I don't know the solution, but I'm working on it.

# **Executive Officer Reports**

*President,* Charlie Arreola: I have the budget for next year that I went through. I printed out the spots that I altered. I gave out more money than Finance Board first allocated, and have the documentation for where that's going. I added \$10,000 to staff salaries to hopefully create two positions for a one year term for recent graduates, someone who wants to be involved in AS. I've been working with Marisela on this, nothing has been finalized. It would just be a pilot program, to keep institutional memory in AS and to provide two more jobs in this tough economy. We don't know what the workload or the job description would be.

I also added money to the main office budget, to build an AS library, would provide for a bookshelf in the office, this is a one time allocation. I want everyone to know that Finance Board allocated zero to the AS Bike Shop, since their funding comes from a lock-in fee. That's the same for KCSB. I increased the President's budget to pay for a new computer. With the Bottom Line, there was a miscommunication with their honoraria, so it increased to \$17,000. Business Services wasn't active this year, so Finance Board didn't allocate them any funds, but I wanted them to start up with most of their funds, so I allocated almost all of what they were given last year. Finance Board didn't fund COPS because they weren't active, I gave them some money for publicity to start up. Same issue with COSWB, gave them \$600 less than they requested, but Finance Board didn't allocate them anything. Rally Committee wasn't active this year, but gave them something to start out with.

*Internal Vice President*, Chris Wendle: It's looking like the election turnout for undergrads is going to exceed the record of 34-35 percent. The Faculty Legislatures is meeting tomorrow, and they're handing out faculty awards.
