## FALL10-03 Gray Whales Count

The primary objectives and purposes of Gray Whales Count, a 501(c)(3) nonprofit corporation, are research and education about marine mammals, including, but not limited to, the migration of gray whales and their related environment: collecting and sharing data, analyzing and interpreting data, recruiting and training volunteers, and engaging in outreach to inform publics. The annual, fifteen-week survey of the northbound migration of gray whales through the near shore of the Santa Barbara Channel is conducted daily by Counters, a team of community volunteers, including students, who document observations from Counter Point in the Coal Oil Point Natural Reserve.

## FALL10-12 From Exxon Valdez to BP's Gulf Disaster: Changing the Endgame

\$625 to support the visit of Dr. Riki Ott to UCSB on October 12, 2010 and to videotape her lecture for sharing with the wider community (and globally). This is a rare opportunity for the community to hear marine toxicologist Riki Ott compare and contrast her direct experience of the 1989 Exxon Valdez oil spill in Alaska and its aftermath with the current oil spill crisis in the

Gulf of Mexico. Dr. Ott was recently named one of the top 10 "Game Changers" of the year by Huffington Post. She is a scientist, author and activist who was present and on the front lines immediately after the Exxon Valdez spill and who continued to fight for a fair settlement for the environment and the people injured by the spill and the ill-conceived "clean up" program. She will share her experience working with Alaskan and Gulf Coast communities and individuals who have suffered human health consequences as well as contamination of their coastal environment.
