## V. BUDGET REPORT

Our budget entails a total of \$171,506.49, yet after removing costs (ie: administration, operative, coastal service program) SPF is left with \$134,695.60. \$4,903.60 is remaining from last year. Our expenses equate to \$3,958.08 and although a larger sum will amount, SPF has \$96,817.00.

#### VI. PROPOSAL REVIEW

# FALL 06-09 "Slough Margin Restoration & Invasive Plant Control at Coal Oil Point Reserve"

Darlene Chirman is requesting funds to restore the margin of Deverux Slough, plant natives to help close informal trails, and control invasive plant species that disrupt native plant communities. The funds will go towards supplies, salaries for the Restoration Ecologist Consultant and Restoration Assistant/Volunteer Coordinator, and seven student interns.

The board felt that our funding was necessary to continue the project that is beneficial to UCSB students (interns and volunteers) at this late date. It was noticed in the proposals that these applicants haven't looked for funding from another source, yet beneficially they will not return to ask for funding this project for a few years. At this point, it is felt that SPF would like to fund the interns, the supplies, and half of the salaries requested. The final decision was to fund \$1000 for supplies, \$750 for the interns, \$1470 for the Restoration Ecologist, and \$1320 for the Restoration Coordinator. Additionally a hourly report will be requested to SPF before our last meeting.

MS Chen: Motion to fund \$1000 for supplies, \$750 for the interns, \$1470 for the Restoration Ecologist, and \$1320 for the Restoration Coordinator with the mandatory hour report.

## Fall 06-08 "Goleta Valley Beautiful Interns"

The organization is responsible of supporting and enhancing a healthy and expanding urban forest, including increasing the canopy coverage in Isla Vista. They are seeking funding for two part-time interns (8-16 hours/week!) to assist the Executive Director with a research project to classify public tress as capital assets using the General

Plan process. SPF discussed that this project exemplifies a very high success rate and is in favor of granting the project the proposed \$500 to delegate to UCSB interns.
