FALL09-08 "Seabird Rehabilitation Trainee/Education Outreach"

Storz talked with CCBER, who did send in their final report and all interns worked their full number of hours doing a range of things, i.e. bottle/syringe feeding. However a student intern was not found to do the website updates (they received no student interns) – instead CCBER paid out of pocket to have a professional website designer. Julia was disappointed that she couldn't get to as many farmers market as she would of liked due to unforeseen circumstances, e.g. there were many more pelican chicks than expected and more songbirds over summer than expected.

FALL09-13 Lagoon Water Quality: Nutrients and Bacteria

FALL10-06 San Clemente Restoration and Stormwater Management Interpretive Signs

The goal of this project is to install 4 educational signs along the perimeter of the San Clemente Restoration and Stormwater management System project adjacent to the new 954 bed San Clemente Villages graduate housing and near the bus stop on Los Carneros Road. The sign topics are: 1) How stormwater management system functions (using data from CF funded water quality analysis) and other information about importance of Low Impact Development; 2) History of the site – how land came to be protected (wetlands, rare plants, land use, Coastal Act, Regional Water Quality Control Board regulations); 3) Restoration goals and habitat types, use by wildlife; 4) Managing for the protected Southern Tarplant. (life history, etc).

FALL10-07 Restoration Intern Training Program

CCBER seeks funding for student interns to participate in CCBER restoration work in multiple sites and habitats from the Campus Lagoon Dune and Bluff restoration to Storke Wetland. Eligible students have generally participated in CCBER's Restoration Intern Training Program in which CCBER Staff provide three or four options for three-hour training sessions per week for a quarter-long internship focused on a range of relevant restoration skills. CCBER is seeking Coastal Fund support for 6 paid student interns per quarter who can follow-up their training with an opportunity to gain in-depth experience working with a project manager.

FALL10-08 Campus Point Restoration

With funding from the Coastal Conservancy and the Coastal Fund, CCBER will be installing a stairway up to campus point from campus beach. CCBER is asking for funding to support student workers and plants for the restoration associated with that stairway to enhance the area, reduce erosion and enhance the aesthetics. They will plant the area with low-growing, coastal species that are adapted to sandy soils on the site. These will greatly enhance the site while also help to keep people on the trails.

FALL10-09 North Bluff Interpretation Signs

CCBER proposes to research, design and install 2 educational interpretive signs for the North Bluff Overlook that is opposite the new Mosher Alumni building on Mesa Road. The two signs will be similar in materials to the past signs funded by Coastal Fund and installed around the Campus Lagoon. One sign will interpret the land use history of the North Bluff and Goleta Slough and the second will provide an overview to the North Bluff Restoration Project, its trail system, and the Ecology of Oak Woodlands: Including use by birds of prey and native plant associations. Signs are based on National Park Service Standards, meet the approval of the Small Project Committee on Campus, and are graffiti resistant. The stands blend in to the landscape and are coated in a rust-resistant powder finish paint.
