## 1. Representative Report

- b. Surfrider: Plans to collect groups (i.e. EAB, Coastal Fund, campus groups) and attend E-coalition once a month. Beach cleanup is 11:00AM 01:00PM. Members of Surfrider have proposed to ban cigarette butts on the beach. The next meeting is Wednesday, Oct 28 at 08:00PM.
- Legislative Council overrode Finance Board to fund Copenhagen.
   Legislative Council was unaware until recently that the exercise and sports minors' budget will be cut.
- 2. Mike McGinnis: the board discussed a concern of Mike McGinnis taking a leave of absence and thus affecting the project proposal FALL09-01
- 3. Update on MLPA meeting: CA must establish marine protection area for its coastal waters. Three plans have been recommended and will lead to one final decision. Another hearing will take place soon, but date has not been set.
- 4. Office Redesign: No proposal has been made to Legislative Council, but draft will be made within the next two weeks by Quentin to send to Marisela for formal request to Leg Council. The Board like to request funding from capital reserves for office improvements.
- 5. Coastal Service Program: The club activity fair last Wednesday was a great success; in response to the flyers handed out, 1/3 of organizations have already submitted applications and 3 email requests have been received. Last weekend 10 groups went out. The CSP average costs have been estimated to \$6200. However, to fund ongoing trail restoration project, an additional \$1800 may need to be allocated.
- 6. Outreach and Education Report:
  - a. "End of the Line": 12 people showed (reasonably good turn-out). Will show film again in Winter for free.
  - b. "Black Wave" Rikki Ott November 12 in the IV Theater 1: the Board suggests helping fund the event so that students are not required to pay but rather donate \$4.
  - c. E-coalition: meeting to collaborate on Monday, Nov 2<sup>nd</sup> 02:00-03:00 PM
  - d. Outreach Budget: proposed budget was estimated to \$23,292. Outreach is suggested to cut down the budget. For the proposed water bottles, Outreach should check the inside lining.

# FALL09-09 Plastic Bag Campaign

CALPIRG planned to organize educational events on campus to build awareness of the environmental problems caused by single use plastic bags, and build support for solutions including using reusable bags and creating a campus policy banning plastic bags from food outlets and retailers on campus. CALPIRG also planned to produce a campaign plan to convince campus administration to support such a policy and implement it; as well as recruiting other campus organizations to join the campaign. The goal for the project was to educate 1000 students on campus, have campus officials agree to the bag ban policy, and have a firm start date for the policy's implementation by the end of the Spring quarter in 2010. However, the board feels that the plans were not concrete or sufficient. The board would like to support CALPIRG in the future, but only under a more experienced knowledgeable project leader.

# FALL09-22 Gray Whales Count

Observation entails experiencing and appreciating the environment around Coal Oil Point and the Santa Barbara Channel.
