#### VI. BUDGET REPORT

The Board currently has \$268,787.00 in the account for grants/projects, plus an additional expected \$23,000.00 from Graduate student lock-in fees.

VII. PROPOSAL REVIEW

#### FALL08-11 Reef Check California

This project proposes to fund the Reef Check Foundation in putting on their Reef Check California program at UCSB to train student interns in monitoring protocols for key rocky reef indicator species. 35 student interns are trained and then participate in surveys along the Santa Barbara coast and Channel Islands. These students learn to identify reef species and collect data on how many species present, as well as conditions. These students will provide essential data that is posted to the Nearshore Ecosystem Database which is available to the academic community, policy makers, and resource managers. This is an excellent opportunity for these students to learn a very pertinent skill in the field of coastal conservation and monitoring. The Board feels that since this is such a highly valued training program amongst students, that they wouldn't object to paying some of the costs involved in the program, such as material costs. The addition of a second student coordinator would provide more opportunities for student interns.

Approval of funding of \$8,855.00 to FALL08-11 Reef Check California

Stipulations: Funding provides for two student coordinators totaling \$2,000.00, half the cost of the boat at \$4,250.00, and Training material costs are reduced by \$4,620.00. Student materials and fuel fee: The board suggests that each of the 35 student participants pay \$150.00 to help offset total costs of the program.

# **FALL08-08 Gray Whales Count**

Gray Whales Count surveys the northbound migration of gray whales through the near shore of the Santa Barbara Channel. 11 student interns will be trained and through their observations they will learn to identify and distinguish various marine animals such as the bottlenose dolphin and the gray whale. One of these interns works direcftly under Dr. Ira Leifer to learn about acoustic analysis. A lot of the community, both locally and on campus, benefit from this project. Last year out of 71 volunteer counters, 40% were unpaid students. The rest of that number consisted of community members coming out to experience counting the whale migration. This is a great way for students and community members to mingle and connect over a critical marine issue in our county. The whale count provides excellent information to researchers and the public on how many whales make the annual trip in the channel. The Board would like to make an addition to this project of two placards to be placed on the two benches out there, one stating that funding for the project was given by Coastal Fund, and a second asking visitors not to litter or leave garbage.

Approval of funding of \$7,777.00 to FALL08-08 Gray Whales Count

#### FALL08-15 Devereux Slough Monitoring Program

The ultimate goal of this project is to continue long term ecological monitoring of the Devereux Slough and to educate students and the community about this unique estuarine system. Continuation of this project will ensure that there are no gaps in the crucial data collection. This project will provide four student interns with valuable hands-on experience with fish sampling, monitoring sedimentation rates, conducting vegetation surveys as well as water quality surveys. This project is an excellent opportunity for students, and crucial to the preservation of the slough. The project also proposes to allocate some of the funding to the purchase of a new water quality meter, which produces data about oxygen in the water, sedimentation etc. This data is integral to analyzing and protecting Devereux Slough, and is posted locally to inform the community. The Board feels that this data collection and analysis is really great information and would like to fund an additional intern whose job is to work on outreach with the campus and community to share what's going on at Devereux Slough.
