## **G-2 Project Review**

## 1 <u>7:30pm Approval/Consideration of: FALL 12-15 - Peregrine Falcons - The Earth's Fastest</u> Animal.

- Eyes in the Sky is a program from the Audubon Society. They have seven birds of prey and do wildlife education programs. This is the main education program for the SB Audubon Society.
- They have just received a Peregrine Falcon. Peregrine Falcons were close to extinction but were restored through a collaborative efforts of several universities. The applicants would like to create a program that focuses on the Coastal Peregrines; always near water and eat and feed on sea birds. Would like to do multimedia presentations for 2 Boys and Girls clubs in the Santa Barbara area: 2 classroom sessions and 1 Field Trip. They work with Three Boys and Girls Clubs.
- Judy does grant writing and works in the Aviary.
- About the Internship, how do you plan on selecting the intern?
  - Prefers a grad student with educational experience and tech savy
  - Will post the opening on the CF website
  - Prefers bilingual
  - Gabriele needs someone who can take over a lot of the curriculum and presentation development while she focuses on administrative duties
- What have you learned from past projects?
  - She wishes to expand the range of the educational programs
  - Now she wants to develop curriculum that matches the bird because each bird has its own story to tell
- Since UCSB students fund this project, how do you justify this projects?
  - The younger generation is not learning this in school and loves the program
  - The information sticks with the students for a lifetime
  - It's for the next generation
- How will the powerpoint be made available?
  - It will be added to the list of available programs that they have
  - Makes it more accessible for teachers
  - Will present PP along with the Peregrine
- What will encourage the students to use the CD?
  - Videos of baby Peregrines and Peregrines in action

- Extra educational information
- Who is responsible for creating the PowerPoint?
  - It will be a joint effort between Gabriele and the intern
- Have you looked into other sources of funding?
  - Have not had any luck finding other sources
  - Manages 43 volunteers so time is too limited to look for other funding sources
  - Audubon provides some in-kind donations but not financial support
- Can the administrative duties be combined?
  - Yes
- Can the Boys and Girls Club pay for their own gas?
  - Not sure, but they usually don't have that kind of budget
- Why three sessions?
  - It's enough to get the kids excited.
  - Three is better than five because sometimes the kids don't come back and their attendance is inconsistent
- Are the kids receptive to afterschool presentations?
  - They are a little squirrely, but they get excited when they see the peregrine and start paying attention to what they are learning

## 2 <u>8:00pm Approval/Consideration of: FALL 12-16 - Gaviota Coastal Trail Planning Study:</u> <u>Opportunities for Coastal Access</u>

We will be joined by Dan Gira.

- Handed out two publications regarding issues on Gaviota.
- Got about 40 new people involved with conservation efforts at Gaviota.

- The county is facing issues: pending development that can change access to the coast for the worst; county is updating long range plan for Gaviota coast; county is not a hard hitting body and is beholden to the development community
- The Trail Council has been actively involved. Have created about 60 pages of evidence that support the conservation of commonly used trails. The county is not currently going in the right direction. Current access will be closed and future access will not be something we want to use. We need to educate the community and decision-makers.
- The trail council has done access improvements and trails across the county to encourage a more natural setting.
- The purpose of this study is to bring on board a design team to prepare an accessible document, graphic rich and simple but enough information to survive peer review.
- How the project pertains to our mission statement:
  - Preservation: To avoid vernal pools and native grasslands with sensitive design techniques
  - Education: trails are interpretive and open many opportunities for impromptu education
  - Access: nicest remaining stretch of coast in southern California; more access with a sensible design the more chance we have at preserving the environment
  - Research: Not as applicable to the project. But we contribute to our understanding of the history of the Gaviota coast
  - Restoration is incorporated
- Map: green line is what state and county think is coastal. Want to put trail behind the 101 but no people would use it; its what the county is approving right now
- Are you apart of the other groups?
  - No, not currently
  - Surfrider and the Gaviota Coast Conservancy are partners; They look to Dan for advice
- How will this study be used?
  - By producing high quality documentation, they educate the public and decisionmakers
  - They interface with county by holding workshops about the study's findings
  - Intended to inform the County's Gaviota Community Plan
  - County will hopefully include this as a full alternative in the EIR. The County staff will
    not recommend a good trail because of political reasons.
  - Want to make sure we have an equal seat at the table with all the planning operations
- When will the trails be up and running?
  - It will happen in phases
  - Depends on the pending development
  - Could take between 3-10 years
- Study area?
  - From UCSB to Gaviota State park
  - Real opportunity to link campus to Gaviota
- The process
  - Get it into the County's EIR; no Draft EIR yet
- What skills are you looking for in your interns?

- Interns will document historic access points
  - Surfrider estimates that there at 70 historic access points and 40 pull-overs
  - Need to conduct a survey; how many cars are parks
- Pull info from existing EIR regarding ongoing and existing access and environmental restraints.
- Will advertise through ES, Bren, and CCBER and UC Reserve
- Want to make this a good document so the intern must have excellent critical reasoning and writing skills.
- 80 hour/each for interns
- What would you cut from the budget if you had to?
  - Probably cut some of George's time
  - They would raise money to make up the difference
- Minimum Coastal Fund amount to make this project happen:
  - They can afford to chip in \$3-4,000
- Why is this the right time to perform this project?
  - Perspectives on Gaviota coast
  - Started 10 years ago
  - They have attempted to fill-in the gap that was left by the County
- Limited amount of groups that fund this sort of thing

#### Coastal Fund Feedback

- Application is simple and easy
- Process is easy

#### Recommend:

\$8,000 total – fund interns in full and then let them figure out the rest

The board believes that this project is important, timely and is crucial to the maintenance of pristine, natural access ways to the beach. This work that will be here for the next 100 years and Coastal Fund can contribute to that legacy.
