VIII. PROPOSAL REVIEW

WINTER09-03 "A comparison of seedling densities and male vs. female sex ratios at five sites around UCSB and within the Santa Barbara Channel"

This purpose of this project is to perform genetic analysis of surf grass, which is a critical habitat for many important invertebrate and fin-fish species locally. This study will provide crucial information for restoration projects. When surf grass is destroyed by anthropogenic sources restorers will be able to successfully reinstate the surf grass by understanding how many plants of each gender it takes to create a successful community of surf grass. Lots of research from UCSB is formed through study of a healthy surf grass ecosystem. By researching surf grass we will be able to gain invaluable experience working directly under an experienced graduate researcher; taking samples, compiling and dispersing information, and analyzing data.
