They have worked with the Jean-Michael Cousteau Ocean Futures Society to create a movie called Harvestor about sustainable fisheries off the SB coast. The proposal would offer internship positions to multiple students, including two positions as editor and producer. The Board is interested in your project and did have some follow up questions we'd like you to address for funding consideration.

- 2. how does this fit within the bigger campaign, why is it necessary to spend this amount of funding on PSA?
- 3. what duties are students be fulfilling as craft services and do they need compensation at all?
- 4 Is the narrator a student? Why is the stipend amount so high if the PSA's are so short (\$500 for a few minutes of reading?)
- 5. how will the PSA's be dispersed? How can you guarantee wide viewing? what outreach will be conducted specifically with getting this PSA out to the community and students of UCSB?
- 6. what is a budget breakdown of expendables? How did you come up with this amount?
