WINTER09-09 Snowy Plover Recovery Program at Coal Oil Point Reserve

However, Coastal Fund would like to see the Snowy Plover Program become more independent. Coastal Fund always supports intern stipend funding but like to see the Program seek out funding from other sources in terms of supplies, and funding for program coordinators. Because of this, Coastal Fund will only be funding the cost of a student docent program assistant, who will be working directly under **Jennifer Stroh** to learn about outreach, grant writing, training docents, and the local species distribution.

WINTER09-05 Environmental Education for UCSB students and K-12 Coastal Ecology Education Program Phase II

The Coastal Fund is always trying to connect community coastal programs with student and campus groups and efforts. The Kids in Nature program is an excellent opportunity for student interns to connect with professors and local school kids and spread coastal awareness. The KIN program has worked with over 1300 children, and hosted more than 15 UCSB student interns. Working as

a KIN intern is a special opportunity to use environmental knowledge, as well as experience working in the education system with children. Interns and students work in garden and coastal ecosystems, examining animals and plants and their role in their respective ecosystems. The children use microscopes, binoculars and other tools to perform tasks. Most of the children that UCSB interns work with from underprivileged families. The backbone of the project is Janet Myers of CCBER. Myers creates the programs and activities, works directly with UCSB interns, and coordinates everything. She also compiles manuals for the interns, as well as an amazing comprehensive workbook of everything covered in the program. Paying Janet Myers' salary is critical to the existence of the project.

COPR would buy an old inexpensive truck, but they have certain university standards that it have to be meet in order to be able to be used. However, Coastal Fund doesn't feel comfortable using student funding to buy a truck. COPR will be receiving funds soon from the university for a large restoration project. The Board suggests that COPR use some of those funds for a truck and apply to Coastal Fund for an equal sum of money to fund another part of the project that CF would be comfortable funding.
