## X. APPLICATION REVIEW

# SPR10-02 "Riparian Restoration at a New University of California Research Station on the Santa Clara River"

MSI and CCBER propose to conduct a demonstration Arundo donax eradication and riparian restoration project along the Santa Clara River, Ventura Co., CA, which will establish self-sustaining native habitat while creating a hands-on learning opportunity for UCSB environmental science and policy students. Students will work in small groups and attend lectures and discussion sections led by UCSB faculty specialists on the key components of creating and implementing a successful ecosystem restoration project. Specialists will then serve as mentors while the students themselves use what they've learned to restore native vegetation and proper ecosystem function at an 8 acre site.

#### SPR10-09 CCBER Native Plant Book

CCBER seeks funding to print a revised set of 200 of our Native Plant Books. These books are a valuable resource for students learning local native plants and participating in our restoration program or in classes.

A suggestion was made that CCBER should to contact Coal Oil Point Reserve and ask if they'd like to use/buy or print more the books as well.
