SPRING 07-06-Analysis of economic, energetic, and ecosystem service dynamics of invasive species removal for ethanol production

Plan to create Create human factor w/ model to use arundo donax as biomass energy. Use ecological, economic and energetic model to see if companies can systematically remove the plant and remove invasive threat, prevent fires with side effect of clean energy.

- Have companies shown initial interest? Contacted a company called Bluefire ethanol, they have a production plant opening in Irvine next year. They are still establishing a working relationship. Have not been in contact with others as of yet. Or send to private contractors, do energy output. (get the numbers for energy output). Then companies would say if processes are compatible.
 - Already given 6k from campus grant
 - Arundo donax already used in Europe as a bioenergy crop (actively grown and harvested)
 - How sustainable is the model?
 - Using santa clara river as sustainable model.
 - Will they lose money in the process?
 - The process of harvesting Arundo is compatible with one plant to another
 - How get word out on this economic model?
