# VII. BUSINESS

## 1. Representative Report

# SPR11-07 Flows to the Ocean Research and Service Learning Project

Funding is requested for a portion of the cost of fieldtrips to Santa Cruz Island for the *Flows to the Ocean* (FTO) Research and Service Learning Project. FTO students learn about local watersheds and how their actions on land impact creeks and the ocean. Students participate in lessons and activities conducted at their schools, the Watershed Resource Center, creek sites, and *OCTOS*, to be located at UCSB. Students take a trip to Santa Cruz Island to conduct beach clean-ups and see first hand how litter from the mainland gets transported to the Channel Islands. As the project stands right now, there is not enough UCSB student body involvement and the board would like the applicant to work student interns into the project with a meaningful role.

# SPR11-08 Enhancing hands-on environmental analysis of the coastal environment

Interactive, hands-on analysis of local environmental data plays an integral role in innovative courses offered by the Geography Department. Several undergraduate level classes allow undergraduates to engage in original scientific inquiry, leveraging real-time and archived data from a nexus of micrometeorological towers. In this proposal, an augmentation to the existing instrumentation infrastructure to facilitate direct measurement of coastal phenomena of great student interest (e.g. fog, land/sea breezes). Deployment of the new sensors, barometric pressure sensors and an infrared radiometer, will be performed with undergraduate interns and will enhance the classroom experience

in several Geography courses. Data from the tower is uploaded to a database in real time. Website to access this database is http://www.geog.ucsb.edu/ideas – click on the "Get Out Data" tab to obtain the data. CF is excited to fund this project because many courses use the information, the data is available to the public, and the student interns involvement is significant.

# SPR11-13 Coastal Stewardship and Policy Program

Coastal Restoration along our bluffs is insufficient in protecting our shoreline and a policy-oriented, broad political and educational effort is required for a healthy and rich coastal zone. This program will establish partnerships with agencies that work on coastal development issues. Student interns will have the opportunity to learn about coastal policy and its applications, as well as the relevance to the ecological integrity and preservation of our shoreline. The program will encourage leadership and increase general student engagement in local planning with outreach efforts that inspire responsible citizenship. Coastal Fund funded \$6115 to this project (Win 11-03) to ensure success and longevity. The UCSB undergraduate applicant is applying for additional funding to continue and build the internship program. The board wants to see this project continue, however with revisions to the budget, which are as follows: Summer session funding was cut from 14 weeks to 12 weeks because summer session runs only for 12 weeks. Also, the Program Coordinator will remain at \$11-/hr rate. Lastly, operational expenses are cut.

STIPULATION: applicant will look for other funding other than Coastal Fund. Further, the spring and summer internships will be completed by the end of summer quarter and the applicant will bring in new interns to begin new projects for this program.
