C-1. Department of Public Worms (Greenhouse ADA-accessible Ramp Vote)

- Jessie Schmitt, our Recycling and Compost Program Coordinator, is working on the addition of an ADA accessible ramp for DPW's greenhouse. The project is shovel ready and only needs an approval vote from a student oversight committee (us).
- <u>Project Description from Jessie</u>: During Spring Quarter, the ECP Student Student had a greenhouse installed to plant seedlings to grow in the garden beds. After installation, we realized that a person using a wheelchair would have a difficult time getting access to the greenhouse. Our goal has always been to make the farm as accessible as possible to everyone. Its difficult to be perfect in an outdoor space as unique as the farm, but it is something we really care about. Therefore, we met with our Project Manager, inspectors and designers to address this issue. A design was created and we would like to get the new ramp and landing installed as soon as possible. DPW has a lock-in fee and has enough funds to cover the costs. We would like to get up to \$3500 approved for this project. (Edit from Controller: These funds are DPW's allocated funds, so we would not have to provide them with any monetary compensation.)
- Financial action item: Jessie wants to use \$3500 of DPW funds to build an ADAaccessible ramp to their greenhouse.
