3. EVPSA (\$250)—Bill Shiebler, The UC Student Association represents all students, educating on propositions that are coming up for a vote. UCSA has created a non-partisan voter guide which outlines priorities and publishes a Q and A with the candidates on issues that affect students. We want to make sure that candidates are prioritizing student issues. We haven't done this before, but it's non-partisan; we want to pass out 2,500 copies, and can get a discount from AS Notetaking. It should cost us 20 cents per voter guide, but we're only asking for \$250 since the AS Fund is limited. Anything that can be donated would be good. We registered 5,000 people to vote in the fall.

Samantha: How much is in the BCC?

Aseye: \$226.40

Motion to give the EVPSA \$226.40 out of BCC and the remaining \$23.60 out of the AS Fund, totaling \$250 (Sam/Nathan).
