### II. Public Forum

## a. IV Youth Projects

Leonor Reyes- IV Teen Center

Children's Center, Family Research Center, and Teen Center that provide opportunity for community members to make improvements and other services in the Isla Vista Community. Asking for \$30,000 for 35 work-steady workers. Finding ways to get volunteers to help with these programs with the lack of funding available.

Alessandra: Are you going anywhere else for funding?

Juan: Funding has been provided by other organizations in the Santa Barbara county. However, none of the funding is set at this moment.

Ruth: IVCRC has a partnership with IVYP. Have monthly meetings with them and have built a strong coalition with them as of last year.

### b. IV Teen Center

Leonor: Asking for \$10,773 to pay for UCSB student staff to lead the YMCA in Goleta. Money will be spent tutoring, mentoring, and facilitating special events and activities. Hopefully a new teen center will be built this year to house more teens in the area.

Kaitlyn: What happened to the mobile units that were used last year?

Leonor: A demo was set and UCSB denied access for the mobile units.

Sam: On average, how many run away teens are there?

Leonor: On average, 5 teens a night are brought to the teen centers.

c. Laughology

Ian: We are excited to be back and continue with our show. Asking for \$7625 to fund this quarter's shows. We are asking IVCRC to fund for five shows (Sep 29, Oct 6, 13, 20, 27).

Kaitlyn: We cannot fund retroactively because the September and early October show has already passed. In that case, we would fund future shows that occur in November.

Liz: How do you advertise?

Ian: We use digiknows, we have flyers, and post advertisements in the Nexus.

### III. Discussion

Ruth: We have funded both these groups in the past and are trying to build a contract with these groups. If there are any issues or requests, they should be addressed so we can move forward and continue building a strong relationship. Megan: They are both big aspects of IVCRC and we need to keep building a strong tie with the community.

## a. IVYP

Megan: We have funded them in full in previous years. IVYP fits in really well with our mission statement.

Ruth: Funding UCSB students and providing a service for the community with this one request.

Liz: There is a whole other population in Isla Vista that we need to care for.

Kaitlyn: It is really important for us to fund a part of it because out of our total budget, this is 20% of our allotment from year's prior.

Ruth: This is a yearlong program that will be more successful in the long run. Beatrice: makes a motion to give IVYP \$27,000.

Liz seconds the motion

Rhandy: What will the extra \$2,000 from last year's funding effect our group? Liz: It is a small difference, but it will give more students opportunities to help out. Alessandra: I would feel more comfortable funding them for the quarter and have them come back next quarter asking for the rest.

Alessandra makes an amendment to fund \$10,000 this guarter.

Rhandy: It will be very beneficial for them to report back to us with what they have done with the money we have funded them this quarter and what improvements need to be made.

Flora: If we gave them the money in full, it would be more beneficial for them because they can do more with the money.

Liz: We have a budget we need to work with and it will be smarter to fund them each quarter. Lots of things can happen and other groups can come to us for funding.
