E. ACTION ITEMS

Rhandy Siordia Anti-Burglary Campaign Stickers funding request

- -request funding for anti-burglary stickers
- -stickers will be distributed to local business to put them on to-go boxes, cups, etc. in order to spread the word about the spike in IV burglaries
- -reminding tenants to lock up before leaving
- -after this campaign was launched last year there was a 30% decrease in burglaries
- -requesting \$2,100 for 160,000 stickers, but only \$800 from IVTU (they are requesting from other BCC's too)

- -this is a safety measure
- -will be asking for funding later, during Winter Quarter
- -county does not want to put up a fence because of liability
