C. REPORTS

- C-1. Hillary on eviction case
 - a. Owner notified of ordinance 44.44
 - b. Been communicating with him via LRC's Robin
 - c. On Halloween, a tenant received a rescission notice the day of her eviction
 - i. However she is still up for relocation benefits
 - d. Today another tenant who has to be out in a month, got a letter saying they have the option to stay and live in a remodeled apartment
 - e. Owner is trying to cover their tracks by giving out these letters saying that the tenants had been offered this option to stay the entire time
 - f. The point of this ordinance is to discourage landlords to displace tenants
 - g. The remodeled apartments are available to live in by the tenants, but for a much higher rent increase
 - i. Owner has decreased price of new apartments for tenants from \$1,495 to \$1,300

- ii. This may be because they have no students lined up to live in them h. next step is litigation
 - i. landlord was lying when he said that he gave everyone the option to stay
- for tenants that have already moved out, they are still eligible for relocation benefits, while those still there will no longer be eligible for those benefits because of these letters they are receiving
- i. Knocking door to door and asking all tenants the same questions regarding options of staying
- j. Also, talk to the students living there now—and ask when they were offered leases/signed them and how much they are paying
- k. IVTU members should research affordable housing options for these tenants
 - i. Type of lease
 - ii. Rent per month
 - iii. 1 or 2 bedrooms
 - iv. availability when?
- I. The Daily Nexus and the Bottom Line have been contacted but a story will probably not come up until after the election
 - Must be careful with the message we want to get out—reporters can twist things around
