2. De prioritize Law Enforcement of Responsible Cannabis use in IV/UCSB; Lobby Government to Tax and Regulate Adult Recreational Use; Investigate Possible Rescheduling Marihuana Based on Recent Scientific Research

Julia – This is to encourage IVFP to de prioritize the fining of cannabis so that the money spent will go to more important issues like rape.

Daniel – This also promotes the legalization of marijuana. And lower the schedule rating so that it is not on par with PCP and Cocaine. The main purpose of this bill is to encourage the use of hemp. Hemp is considered pot even though it does not produce the same effects when smoked. The legalization will promote sustainability in our state.

Raymond – I think that this bill is great and that we should pass it today.

Raymond read the bill.

Shahan – This extends what was approved earlier this year with Measure P. I think that this is a good message and promotes good policies within IVFP. This is a step in the right direction.

Julia – I just wanted to point out Measure P.

Jaclyn – I think that de-criminalizing is a great idea, especially in our violent crimes. I think that we should include the studies findings and where the studies came from.
