#### **Announcements**

<u>Nick Allen, EAB Co-chair</u>: The Climate Conference is this Friday at Corwin Pavilion from 10am to 7pm, where we're bringing back what we learned at Copenhagen, it will have three panels that will bring together grassroots activism, business, and government, wince we noticed in Copenhagen the disconnect between these three parts of climate improvement, in order to try and form a more holistic solution. We've gotten a lot of publicity on this event. We're also holding a second day of the conference about sustainability, Saturday 9am to 3pm geared towards freshmen.

Andrew Trindle, Judicial Council Chair: I'd like to read the decision to you, for clarification the petitioners means Elections Committee, and the responded means Legislative Council.

"Andrew Trindle, Writing for the Majority. Joined by Alexa Greco, Ryan Malloy and Jordan Wolfe.

Petitioner ASUCSB Elections Committee alleges that respondent ASUCSB Legislative Council violated the Petitioner's jurisdiction by passing Directional Resolution 030310:87, "A Resolution to Keep Party Names on the Associated Students Election Ballot" (Petitioner's exhibit F). This resolution instructed Elections Committee to leave political party names on the ballot. Elections committee argued that this action violated their jurisdiction as established the *By-laws of Associated Students of UCSB (By-Laws*), Article XIV, B1.A. The petitioners argued that the ballot falls under "all jurisdiction in regards to elections rules, policies, enforcement, and promotion at all times during the Associated Students election and campaign." Elections Committee also alleged that a conflict of interest, as defined by Policy 6 of *The Standing Policies and Procedures of the Associated Students of UCSB (Standing Policies*) existed because some members of Legislative Council had declared candidacy to run in the election.

Respondent Legislative Council argued that Article XIV, ß1.A only granted Elections Committee "full" jurisdiction during the narrow period of the election and campaign. To establish this time frame, Legislative Council turned to By-Laws Article XIV, ß3.A.2, which establishes the beginning of campaigning as 8:00 pm, the third Sunday of Spring [Quarter], and continuing through the election, which is held "during week 4 of Spring Quarter" (By-Laws Article XIV,  $\beta$ 3.A.3). Furthermore counsel for the respondent argued that Legislative Council acted within their legislative capacity as set out in Article V  $\beta$ 1 of the *Constitution of the Associated Students of the University of California, Santa Barbara* (*Constitution*). Council argued that the Directional Resolution met the requirements as set out in Policy 5 in the *Standing Policies*, and thus must be followed by Elections Committee. In response to Petitioner's argument about the alleged conflict of interest, the respondent argued that Policy 6 was narrowly defined to "any Committee or Board," and thus not applicable to Legislative Council. Respondents also argued that their votes were motivated in the best interest of the association.

Upon submission of the arguments and evidence, Judicial Council deliberated over the issues presented.

With regard to the issue of jurisdiction, the Council agreed with respondent's argument that Elections Committee retains "all" jurisdiction during the election and campaign, with the note that the Constitution, in Article IX B2 states that the "General Elections shall be completed by the fifth (5th) week of the Spring Quarter." However, we find that there are contradictions within the Legal Code, which prohibit this Council from making a determination on jurisdiction, or the extent there of, outside of the campaign and election timeline enumerated above. By-Laws Article X B15 C. 8, as mentioned in the Petitioner's case brief and opening statement, establishes that the Chair of Elections Committee "shall have jurisdiction over all Associated Students elections related processes during the academic school year." No arguments were made on this point, and Judicial Council was unable to render a decision based upon this point. Judicial Council recommends that Legislative Council, in full consultation with Elections can be drawn, and responsibilities of both parties be understood.

Elections Committee's argument about the conflict of interest does bear some consideration. Elections Committee provided minutes from the March 3, 2010 Legislative Council meeting (Petitioner's exhibit G) illustrating the vote of each Legislative Council representative regarding the Directional Resolution (exhibit F), as well as a list of the candidates running (exhibit I). Limited testimony was given regarding the issue of conflict of interest, but the issue remains relevant because it was mentioned in the Petitioner's case brief, as well as their opening statement. Furthermore, Counsel for Legislative Council argued that Mr. Miles Freeman, a witness for the petitioner and a candidate running in the Spring General Election, was engaging in a conflict of interest because he assisted Elections Committee in preparing for the hearing. Yet counsel for Legislative Council argued on objection that Legislative Council could not be held to Policy 6 because Legislative Council is not a "committee or board" as stated in the Policy. Judicial Council finds that this argument is too literal a reading of the policy, and that conflict of interest encompasses any and all parts of the Association, whether they be Boards, Committees, Commissions, or Councils. Based upon this, rules governing conflict of interest would have applied to the vote to pass the directional resolution.

Counsel for the respondent also objected to the conflict of interest argument, stating that the Petitioner was speculating as to the motives of individual council members. However, Policy 6 does not contain any language pertaining to motive. Instead, Policy 6. A provides 3 separate conditions for determining a conflict of interest. Part B of the policy states that "if a conflict of interest is determined to exist, by the individual member(s) or the Committee or Board as a whole, the member(s) unable to objectively discharge his/her responsibility shall abstain from voting on said matter(s)." As demonstrated by the Cross examination of Mr. Freeman, persons running for a position in Associated Students that receive honoraria meet the requirement of a conflict of interest because of their "personal financial gain" (Policy 6, A. 1). Accordingly, those persons who are running in the Spring Election should have abstained from voting, yet the recording of the vote found in Petitioner's exhibit G shows that there was only 1 vote that was listed as "pm". When examined against exhibit I, the Council finds at least 4 representatives who refrained from abstaining who are are also candidates in the Spring Election.

In conclusion, Judicial Council finds for the petitioner, in part. The disregard for the rules pertaining to conflict of interest affected the voting on the Directional Resolution (Exhibit F). Regarding the issue of jurisdiction, the Council affirms Respondent's interpretation of By-Laws Article XIV,  $\beta$ 3.A.3 to pertain to the 3rd, 4th, and 5th week of Spring Quarter, at least for the Spring General Election. The legal code is vague beyond this point and Judicial Council cannot render a ruling on the question of who retains jurisdiction outside of this time. To address this matter, we strongly urge Legislative Council to consult with Elections Committee to address the contradictions noted above. Directional Resolution 030310:87 "A Resolution to Keep Party Names on the Associated Students Elections Ballot" is hereby overturned."

Beth Goodman: Does that mean that Legislative Council still has jurisdiction?

Andrew Trindle: I can't comment on that, there was no evidence for us to make that definition.

**Brittany Middleton:** Committee on Committees is working very hard on publicizing open positions for next years, you've all seen the boards along the bike path, we're trying to get as many BCC members out for tabling next Tuesday in front of the Annex, so if you can tell committees to help us out, and if you could come by and help out if you can that would be great.

#### **Public Forum:**

**Michael St. John:** I'm disappointed to hear that party names are going to be taken off, and I'd like to respectfully disagree with this decision, since it would eliminate the significance of the parties, since the party name gives me a frame of reference to who follows in line with me politically, since I could side with a certain party to vote for those people that I don't know, and I don't think that is a unique way of voting, since people don't have a lot of time to research each individual candidate.

<u>MOTION</u> made by Adam Goldman, <u>SECONDED</u> by Jake Elwood to give Michael St.John three more minutes. <u>MOTION CARRIED BY CONSENT</u>.

**Michael St.John**: Parties are involved in all national elections, and if they took parties off of those ballots there would be riots. Please don't approve any ballot without party names.

**Abby Cordova**: Are you trying to say that you'll vote for a group of people whether they're qualified or not?

Michael St.John: I'll vote for that party whose line I agree with.

**Miles Freeman, Attorney General**: I'd like to point out that the horse is dead, we've beaten this elections thing to the ground, my only issue is that this may establish a bad precedent, that anytime Elections Committee does something that Legislative Council doesn't like, then Legislative Council has that legislative veto, it's like tyranny. I agree with a phrase I heard once, that legislators should legislate.

## AS Committee & Ex-Officio Reports

**Pratish Patel, Finance Board Chair**: You made the ASI allocation decision last week, there was some talk about what's going on with Program Board gaining back the money they gave to ASI, I talked to Kathleen and Marilyn, and Program Board will be making back what they put in, \$13,000, with an additional \$100 or so, if that's a concern, we can discuss it. Secondly, the unallocated funds are slowly dwindling, we have around \$77,000 left, we need to be updated if there's an increase in honoraria, because I don't know how it will affect our budget yet, and I would appreciate that information ASAP. I'm meeting on Friday night with Captain Farley to talk about the large security cost student groups have been asking for, since there's been a discrepancy for certain events and the number of officers that are required, and the Council of Chancellors has forwarded us a document created on 6 April 2009 that states no UC campus can determine how much security is required determined on who is speaking or the event, only the length of the event or the venue. I'll ask him what criteria they use.

## Executive Director's Report: Marisela Marquez, Ph.D.



**Charlie Arreola**, *President*: Last quarter I met with Allen Kirby to look at the technical needs for where you all meet, which could be a special project for someone, we've got the go-ahead to install stuff in any room, and we'll get priority on using that room. If you're

interested I'm trying to get students on the minor events committee, which looks at events that have 2000 or less students, if you're interested in event planning or coordination. I'm exploring with Marisela the grant writing program to get UCSB student experience with writing grants while at the same time helping out local Goleta and Santa Barbara community organizations who need funding. Trying to get an event for constituents of the Chicano/Latino community, where everyone can come together and drop their affiliations and discuss what our community needs to improve on. Chicano/Latino culture week is the week of April 26th, want to create a mechanism such as a forum to talk about the necessity for Chicano/Latino students on campus, since we're almost an Hispanic serving institution. Student Regent selection committee is going to interview 9 candidates, I'll update you on that process. I sit on the Chancellor's Committee on Budget Strategy, discussing the instructional technology enhancement, one of the points in the proposal is discussing with other colleges to explore getting a fee. There's been some talk about IAC and Rec Sports merging, but there's some concern if that happens athletic students will be prioritized. Immigration Rally is tomorrow at noon at the Arbor, and at 8pm there's the Hate Crimes Form about what happened at the later part of last quarter. The Multicultural leaders symposium is next Tuesday, April 15th at 5pm, you have to rsvp for that event.

## **Group Project Reports**

**Mike Hewitt**: Greeks Gone Green is selling canteens for \$10, we're continuing doing the audits on all the houses and setting up a recycling system with AS recycling so the houses don't have to sort their recyclables themselves. There was some discussion about undermining funding for families in IV who rely on money from returned CRV for cans, although it's illegal to go through people's recycling, we'll probably donate some money back to the community.

Alexandra Onodera: The t-shirt printing has come to a stop since there's an IV screen printing business who's doing really well, so if anyone needs help on a special project I don't have one anymore.

**Barbara Goodman**: If you haven't heard, the Board of Supervisors has closed the beach for Floatopia, and they said that they're prepared to close down the beach every weekend. There's a website up and it has all the information. The County tried to get Chris Par to legally hold Floatopia, and gave him all the insurance and permit information, but he

went full throttle and got thrown out of the board meeting by cops. It might not be right, but the county pays millions in damages for this event, and they have to cover their ass somehow.

**Charlie Arreola**: This would be the best time to utilize Clay's office, since he's in communication with Lt. Olmstead and IV Foot Patrol, and he'll be looking at the legality of them closing the beach every weekend.

Mike Hewitt: Is there any options for institutionalizing the event?

**Beth Goodman**: The only issue was that the insurance was too expensive to cover everything, even though the money they're going to spend closing the beach every week could probably cover that cost.

## 2. Approval of Spring 2010 Ballot

**Chris Wendle**: Just to make the judicial ruling clear, the resolution for including party names in the ballot was overturned, but their decision didn't specifically say who has the call on whether party names are put on the ballot. Old Business 1 will be striking the line that gives authority to the chair of Elections Committee, which gives the chair jurisdiction over everything Elections Committee does, but if that passes tonight it doesn't come into effect until next year, it does not affect this year. We'll be bringing up the resolution for including party names on the ballot again, and I'm sorry I was supposed to allow you to abstain from voting if you have a conflict of interest on this vote. I talked to the staff and the executives have the right to interpret whether Legislative Council or Elections Committee has authority over this situation, and the Chair and Vice chair from Elections are coming into talk to us later. I will allow for abstentions as Judicial Council has ruled. For the proxies you're here, like Joel's proxy, you have to abstain if the person you're representing is running.

Chris Wendle: They need this by tomorrow morning, so we need a vote by tonight.

**Beth Goodman**: I know this was a contentious issue, and that it went to Judicial Council because Elections Committee didn't follow our directional resolution because of an error made by the chair, and we're bringing it back now to legally pass this directional

resolution through. Elections Committee is a BCC over which Legislative Council has authority, and we should keep the party names on the ballot because we already voted and passed this.

**Elizabeth Farrington**: We could tell them what to do, but Elections Committee was create to solve these problems and make these decision, it's no sense to undermine their choices, since in the long run it doesn't make much of a difference, and if they're not informed, then they're not informed.

**Chris Wendle**: The issue right now is that we have to decide if the EC chair has that authority or not, because Judicial Council didn't have enough evidence to say who has authority over this issue, and it's up to interpretation by the executive branch of government.
