Based in the Interdisciplinary Humanities Center (ICH) of the University of California Santa Barbara, Isla Vista Arts promotes the arts as a catalyst for social growth and change in the neighboring Isla Vista community. IV Arts approaches Isla Vista as an asset to the UCSB campus and the surrounding Santa Barbara and Goleta community. IV Arts aims to promote a habit of cultural attendance. In order to accomplish this, we believe arts programming needs to be presented and promoted habitually. IV Arts co-sponsors weekly arts programming, such as **Magic Lantern Films**, **IV LIVE** and **IMPROVABILITY** as well as on-going projects like **Shakespeare in the Park**, **WORD: Isla Vista Arts & Culture Magazine**, **Nuestra Voz**, and **The Box**.

Duties of all Isla Vista Arts Board Members:

- Review funding requests submitted to the Board for Isla Vista arts and culture programs.
- Hold a *minimum* of one (1) Isla Vista Arts Board office hour per week.
- Attend a *minimum* of three (3) Isla Vista Arts events per quarter, including but not limited to, Magic Lantern Film viewings, Improvability Shows, Shakespeare in the Park, editorial meetings of Word Magazine, or the BOX opening receptions.
- Attend all Isla Vista Arts Board meetings.
- As a board, plan *at least* one (1) collaborative event per school year.
- Allocate Isla Vista Arts funds to Magic Lantern Films, IV Live, Word: Isla Vista Arts and Culture Magazine, and The BOX.
- Review and approve the expenditures of organizations granted line item funding in Isla Vista Arts Board's budget.
- Aid in the advertisement of any arts or culture event in Isla Vista.
- Allocate funds to other arts and culture events in Isla Vista that fit within the mission and charge of Isla Vista Arts *if there is adequate funding available and if Isla Vista Arts collaborates with the organizers of said events*.
- Meet a *minimum* of one time per academic quarter, with the exception of Summer. The meeting will ensure that any old business is tended to and will provide members with an opportunity to bring the Board's attention to any new business.

WORD Magazine Representative:

Among other duties, the WORD Magazine Representative will attend all events related to WORD Magazine and provide the board *at least* one detailed report on WORD Magazine's use of IV Arts funding per quarter.

IV Live Representative:

Among other duties, the IV Live Representative will attend all events related to IV Live, Improvability, The BOX, and Nuestra Voz and provide the board *at least* one detailed report on the use of IV Arts funding per quarter within those programs.

Magic Lantern Representative:

Among other duties, the Magic Lantern Representative will attend all events related to Magic Lantern and provide the board *at least* one detailed report on Magic Lantern's use of IV Arts funding per quarter.

Chair:

The goal of the Chair is to act as a mediator and facilitator during the Board's meetings. The Chair of Isla Vista Arts will meet regularly with AS staff in order to discuss concerns and important issues, as well as attend at least one Senate meeting per quarter to give an Isla Vista Arts board report detailing events, programs, projects, and ideas the Board has been working on. The Chair will foster the growth of the IV Arts Board through leadership on new ideas, projects, and programs. *At least* twice per quarter, you must meet with the advisors to discuss the Board's performance and projects.

Vice Chair:

In the event that the Chair is absent from a meeting, the Vice Chair will temporarily take over the duties and powers of the Isla Vista Arts Board Chair for the meeting. In the event that the Chair position becomes permanently vacant, assume the role of Chair of Isla Vista Arts Board. The goal of the Vice Chair is to assist the Chair in mediating and facilitating Board meetings, meet regularly with A.S. staff to discuss concerns and important issues, and foster the growth of the Board through leadership on new ideas, projects, and programs. The Vice Chair *must* take minutes of each Isla Vista Arts Board meeting and submit all meeting minutes to the Internal Vice President for Senatorial approval.

Social Media Coordinator:

The Social Media Coordinator will operate any and all Isla Vista Arts social media platforms, as well as keep students up to date with I.V. Arts events by advertising said events online.
