# Siddiqui

- Since there are lots of resolutions would appreciate if people would click on the legislation to show respect
- Had in mind for a while after convos with many stakeholders, staff, senators
- Important because the greatest tool of leverage we do is collect student fees, over 18 million from undergrads
- Our responsibility is to make sure our students are getting the most back
- Reason why were seeking to move away from montecito bank and trust, there's a plethora
- One-the money that is in our accounts with this bank, oftentimes they're not even collecting market rate, interest returns
- Bc it is a regional bank and not nationally accredited, there's lots of services we're missing out on
- In the resolution, we cited that we as senate are a legislative body
- Makes sense that we want the highest quality bank with the best return rates for UCSB students

# Lala

- Dan put it really well
- This is just basic step in upholding our judiciary and representative duty to the student body in the best way possible

# ■ A Resolution To Adopt The MIP Cloud Financial System Software Siddiqui - Singh

# Siddiqui

- Similar to last piece, would appreciate if everyone clicked on link as show of respect
- Been working with finance team and others in association to figure out how best we can serve students
- A lot of issues that we see happening in association due to fact that were still on paper and pen requisition system
- Two, our training resources, websites, management systems, TLDR: we are vastly behind every other AS
- TLDR we are vastly behind in terms of technology especially moving our finances to the internet
- Digitizing our financial system, something that vast majority of non profits have done in this day and age
- Micheal has been working w/ UCSB admin to see if we can adopt MIP cloud financial system software
- Essentially change AS as we know it

- Digitize finances
- Requisitions signed online, senators viewing entities' budget accounts and transactions online
- We would be able to go into any entities account, view budget, transactions, etc
- Get us back up to date with other AS'
- Marissa and Sean working to update BCUs and upload them to shoreline and have accessible roster lists of members
- Kalia(previous IVP) worked on two major projects during his term that he wasn't able to implement
- One, accounting rework act, kind of similar to what MIP is doing, except there were other things in there that would allow units to earn money on their accounts when storing them
- There's also the data management system that he created that is kind of similar to what Marissa and Sean were doing
- Along with MIP, this committee is gonna hold meeting with Sean, other stakeholders, making sure we're cohesively digitizing assoication
- Our project isn't interfering with another but overall goal is that by start of 76th Senate and fall 25, everything in AS would be digital, trainings, FnB, purchases
- Think this is monumental, no brainer
- Shouldve been done a while ago

#### Singh

- Nothing to add, you covered everything

### Iden

- How many ppl have seen the actual proposal?
- Assuming its limited number
- I'd like to have everyone have the information available to them
- Very upfront cost
- 98,000 for the first year
- Everyone should be informed on this decision
   Would like to have michael come and talk to us

# Siddiqui

- In my convos with michael, he made it apparent that this is a time-sensitive legislation that needs to be passed
- I understand your concerns abt cost, but it's not coming from senate unallocated or FnB
- Didnt specify which account it would be from
- We need to look at ROI
- If we're gonna spend 98,000 on something that will change the way AS works forever then
- Want to say I understand where you're coming from about Michael but the committee has had a lot of time to talk to michael
- Would like to see this go to a vote today

#### Pinto

- Is 98,000 yearly or just to obtain the software for life

- Recurring cost

#### Iden

- Upfront, every year after is 35,000
- I have some issues
- Never met with michael
- The fact no one has looked at it and we're asked to pass almost 100k
- Very unethical to me, floating it as a big rate thing
- Feels very strange that michael isnt presenting to us
- No one rlly knows how accounting software works
- These procedures are not okay

Marissa would you like to provide insight

# Martinez

- Met w/ michael, did talk about this as well, marissa can go first before my opinion

#### Marissa

- MIP is also used by berkeley AS
- Did put michael in touch with berkeley FnB
- Did have convo abt pros and cons of it
- Not an expansive search, narrowed down to two softwares
- Want to provide that I know the accounting software works well
- Didn't use cloud while at berkeley so the version ur doing is better
- I do agree it's a big upfront cost
- Can text michael to see if he can pop on
- Know it works in other AS

#### **Martinez**

- Haven't been as exposed to all of the conversations and research they've done
- Have had pleasure of meeting michael, did speak about system relating to financial questions I had toward assoicaiton
- Strongly feel like this would be a very good investment
- Especially for FnB
- Outdated, need twice as many ppl to work on paper
- It's important to take into consideration the cost, but should also speak to micheal
- Good investment to make for AS
- Think this would be very helpful in the long run
- Doing as much research as possible
- From what I spoke with michael, think it's a good investment to make

# Khorsandi

- Want to echo what senator Iden said
- I do agree that we need to be digitized
- Bc of the weight of the finances of this, lot of money, think we need to place importance rather than passing it faster
- Need to take a little more due diligence, have Micheal come speak to us
- Dont even know where this money is going to
- Where is the money coming out of?

- So many unanswered questions
- Would be more appropriate if we got more info before we rushed to pass it

#### Pinto

- I would like us to consider how deeply understaffed AS professional staff is
- Consider this investment into software as having to not need that much staff
- Do currently have a member of FnB despite being temporary position, here to share some insight

#### Amin

- Completely agree with Iden and Khorsandi
- Will say that pushing this so quickly is not in our best interest or the student bodys
- If we take more time and we're actually able to bring micheal into senate meeting next week and then vote it'd be better
- Dont think rushing 100k is good idea

# Lankarani

- Agree with sentiments of being rushed
- Want to echo acucar, our professional staff is very understaffed
- Perspective from my last requisition work, was on CAJJ
- Mostly in charge of requisitions cuz we didn't have anyone looking to be treasurer
- That's where we struggled the most
- Ran the series on frequent basis where we would be paying musicians to come to event
- Our requisitions were not getting processed in a very quick manner
- These are people's livilehoods and jobs
- They need this money to pass their bills
- Having more expedited process for requisitions sooner the better
- If we can't get michael here to do presentation, we could do email vote
- Would just like this resolved as soon as possible

#### Pinto

- Want to remind everyone we do gave a member of AS financial team here
- Doesn't all fall on michael
- Very understaffed, fact we dont have digitized systems makes it slow to get paid
- Shoutout to michael
- Onboarding process is 9-10 months long for staff member
- This process could make it easier
- Would like to invite Vincent Ton to speak

# Vincent Ton

- Before I get to the questions, do want to acknowledge the great points being made on two sides of this debate
- Important that it happens as soon as possible
- I was apart of AS, currently serve as staff advisor for BCU
- I get the embarrassment of dealing with 3rd party vendors
- Bc of the process we have, 3rd party vendors get paid late

- We've all gone through that where someone's emailed us asking where the check is
- Always been a paper check
- Us as student leaders explaining to members in our group, bc we don't have association wide credit card, it takes a while for students we work with to get reimbursed
- To senators who raised point of this being traced back to pen and paper system
- Understanding concern of high price tag
- One of the first times you deal with big contract price tags
- At caltech lots of software has big prices
- I don't even know what the upfront installation charge is, something from 90-100 thousand
- With clear conscience, you should vote on this
- Clear conscious will come to you when you vote
- Marissa mentioned software was used at berkeley
- Its been used at University of Georgia, other big universities are using MIP software
- You should all take the time to review what it looks like on other college campuses
- Wrote down notes on points raised
- Micheal is leading the charge yes, kudos to him
- All staff hands on approach
- Gonna answer questions
- Hope that a decision can come quickly
- When academic year hits, we find ourselves with a lot of work
- Look into what could be a fundamental change within association

#### Michael Cea

- Happy to take quick questions

#### McClintock

- Just wanted to bring up from my POV as board chair
- Having something digitized would be so helpful in getting events to happen
- Didn't have ability to pay our vendors
- Multiple ppl had to pay out of pocket on our credit cards
- We talked a lot during budget cycle aboutt boards not spending their money
- We weren't getting the money to spend
- Talked to marissa last quarter about digitizing
- Coming from great stand point
- Think about it today and maybe do email vote
- Current software cost 50k a year, this new way will save us money
- Vote before first october meeting before school starts

#### Pinto

- Yes the current money being spent is an excellent point

#### Ton

- One of the big features of the new software implementation will be direct deposit

- Thinking about all the checks made, lost, students scrambling to find money for their own rent
- As student myself, I valued the students who were able to put down their credit cards for the association
- This is an equity issue
- Direct deposit is big plus

#### Pinto

- One question repeated is where is the funding come from

#### Ton

- Will defer to whatever michael says on that

# Michael Cea

- The idea of where the money comes from
- 3-4 months of evaluations
- 30+ page document I've circulated
- If we don't start implementation during september then we're delaying implementation
- We have a spring target to test the software
- If we don't meet our deadlines we won't have it for the next cycle
- Certainly have to design the work flows, lot of committee effort and student groups
- Gonna need to be integrated with our existing data
- Important to get started on
- Why we need it has been raised
- No way to have transparency until you have a digital real time system
- No way to know your budgets unless you're able to log into your specific accounts, what your remaining budgets are, what's learned and therefore what's available to spend
- As vincent points out, the direct payment model is essential to any modern system, ACHs, batch uploads, direct bank connectivity, reconciliation
- Whole many reasons we're doing this
- Failed to implement infrastructure upgrade for decades
- Other campuses leapfrog us multiple times
- Paper workflow delays everything
- All criticisms are real, justified
- Lot of waste in our current system
- The build up of capital is where the funds will come from
- We have a reserve account, over 2 million dollars in it
- 9-10 million dollars in general in terms of all the lock ins
- Focus on our core mission of delivering results

#### Marissa

- Question in chat "So would the 50k annually for the current system be replaced by the 35k or would the 35k be an additional annual cost?"

#### Micheal

- Current market license calls for similar systems

- Blackboard system costs more than MIP, this is a good deal
- The cost of implementation has built in hours and hours of software engineers
- The idea of saving money over time is real
- Optimize our funds if we adopt new sysetm

#### Marissa

- "Under this we will be more efficient and save money over time?"

# Michael

- Yes

#### Vincent

- I'm happy to take notes on any further questions, will relay those to michael, will circle back to you guys as soon as possible

# Michael

- Last point, if there is possibility of circulating the documentation I've supplied, there is a time frame
- Needs to be considered reasonably quickly
- That would help

#### Zha

- In interest of time may I propose that we skip the resolution for the moment to give time to digest the information just learned, and read the valuable document
- Can circle back to resolution at the end

- Will revisit this resolution

# Iden

- Point of order, I've had my hand up, don't feel it's fair to move on without the last final thoughts being on this

# Pinto

- As long as it's relevant and adds more points rather than repeating

#### Iden

- Issue is that for future meetings if you're gonna bring something with 100k price tag
- I'm all for online honoraria
- No one has looked at it, and I didn't know there was a time frame on this
- If were going to be working for the rest of the year, you want senators to know the info
- Software looks great, things on it are awesome
- For future, someone needs to have info brought out sooner
- Majority of senate hasn't seen this
- This doesnt happen in the real business world
- You dont get told there's a deadline and then have to force everyone into voting a decision when they don't really know about it

#### Pinto

- This was sent out a few weeks ago

- I have checked it personally
- It's a responsibility as senators that we're taking on, important to stay on top of that
- Also Senator Medeiros brought up that we're not in regular meetings so that does give us more opportunities to go ahead and review the material ourselves
- Goal is to serve fellow students
- I hear your concerns on price tag, overall, does seem more cost efficient
- We'll be replacing an inefficient system that will overall be allowing AS staff to have more room and have these convos with us

# Siddiqui

- Two quick points
- Thank you for bring up the fact this was emailed weeks ago
- In the real world, it is your and your responsibility alone to check your emails
- Be aware of all legislation brought out
- This piece has been on the agenda for 10 days
- Every sole person's individual responsibility to keep track of emails eent out to thims
- With all due respect, this is an individual responsibility
- I understand it's summer, but your terms are year round
- If you're getting paid for summer, you should be doing your job

#### Iden

- Nothing in my email but the initial one.

#### Pinto

- If any of our staff members or pro temps have that readily available, please send that out again to our current senators
- Maybe some type of email list mix up

# Zha

- At page 138, of the digital code, where is says we're discussing the implementation
- Basically decides authority of the decision making for new procurement procedures first under FnB
- Might be able to circumvent that by calling special meeting of FnB, just realized we don't have enough for that
- Senate can only pass this by majority vote to interpret this clause as not including the new procurement system
- Senate is responsible for interpretation of legal code unless challenged
- If senate wants to interpret this clause in a way that doesn't interfere with the passing of the new procurement system
- It's your choice
- I'm referring to MSI procurement system resolution

# Siddiqui

Confused as to why you said the finance committee couldn't meet quorum

- To my understanding they have their officers and chairs more than 2/3
- Why would they not be able to call quorum to hold a special meeting

# Zha

- Let's say the FnB committee only had Senate senators, then we could call FnB meeting within senate meeting
- Since there are 11 or 13 ppl under FnB, we cannot just call special meeting of FnB within the Senate meeting
- So they can meet outside, but we cannot call special meeting

# Siddiqui

- In that case, finance committe chair can hold email vote for this, they propose amendments, then it comes out of the committee, and then we'd have to come back to Senate for us to pass with amendments or not pass

# Zha

- Fnb has exclusive jurisdiction and decision making over new procurement procedures
- FnB alone is entitled to make that decision without any input from the Senate

# Siddiqui

- So they can pass without a committee?

# Zha

- Yes

#### Pinto

- So seeing we have this bylaw
- Would someone motion for the resolution to be sent to FnB?

# ■ A Bill To Restore and Repair ASUCSB Online Presence Siddiqui - Iden

# Moved here 7:56pm

# Siddiqui

- This leg is aimed at correcting a pletothora of issues
- This is a bill so i think it'll be tabled, more amendments to be made
- 8 total viewers on agenda, would like to see people looking at legislation your fellow senators worked hard on

- Main objective of this legislation is to fix our broken online presence
- Completely outdated
- Marketing is vastly behind at where it could be
- Coulld be having way more social media accounts
- Could be posting way more
- Reason that it'd be beneficial is bc we're the premier instituion
- We are the premier institueion on representing undergrad studens
- Undergrads are either unaware or unable to truly comprehend what AS and its entities do
- One of these examples is the AS food bank, since it's introduction it's cut down food insecurity by 50 percent
- Ppl don't know about that bc we don't do a good job of marketing ourselves
- That's why we have low voter turnout besides this current one
- Lots of senators, hardworking executives, BCU chairs, who put on great programming for student body
- This bill takes away the two public relations and media coordinator positions in the IVP office
- Delegates it to a senate media coordinator and an IVP media coordinator, manage social media websites
- Senate media coordinator would run Senate instagram and websites, same with IVP media coordinator
- The chief compliance officer position is weird
- It was put under FnB
- Within its legal code under FnB, says that the IVP is the person who appoints them, and that they're in the IVP office, but there is no CCO description within the IVP's office's legal code
- I think no one just added this
- What this does is get rid of that redudancy
- There was a bill passed last year that allowed CCO to create their own office
- David Jr. Sim is CCO this year, he's fantastic
- There's a part in here pertaining to go gaucho
- Pertaining to go gaucho, alvin and SAG office working on that, will contact him

# Iden

- Going into start of school year, this is something we need to think about
- Making yourself known and putting yourself out there is important

#### Khorsandi

- Wanna say thank you for writing this bill, really important to maintain online presence, its really bad
- Not sustainable for how we are trying to show ourselves
- Senator Butler and I had idea of ppl being able to transparently see the legislation that were passing, that's the most important part
- Reading through the bill right now, will the senate media coordinator be responsible for the website?
- How is that different from the web developer director?
- Do you wanna absorb them?

- Would that be more beneficial
- Or are we keeping them separate

# Siddiqui

- Better to keep positions separate bc reason our marketing efforts have been so bad
- The responsibilities have never been delegated to a specific person
- Reason why it hasnt been update in so long
- All those positions are busy doing something else, don't think about doing it
- Web development director should upload the minutes and agendas of senate each week
- In past, put too many responsibilities of a position
- When khorsandi and butler created the web developer position, was there a financial impact for that?

# Khorsandi

- Wrote yearly financial impact of 900\$

#### Butler

- I think you're correct but I'd definitely cheek my answer

# Siddiqui

- Ok would just be something to correct in later meeting

# Khorsandi

- Confirming yes in bill it says \$900 impact

# Siddiqui

- Yes we need to figure out where the money is coming from
- Need to figure out which honoraria account
- Each account only has a certain amount of money

# Pinto

- Would suggest we keep 'head' or 'position' of internal compliance officer because chief is disrespectful
- I suggest someone motions to table the bill into our next Senate meeting Siddiqui
  - If we leave it does it just get tabled automatically?

#### Zha

It will be better if you pass motion to table it until next meeting

Butler - Amin

Call to question - Lankarani

This motion passed at 8:10 pm.

#### Butler

- Essentially this is a temporary standing committee established last year by the president
- Not a lot of changes I made for this year
- Had meeting with our president a few weeks ago to understand this space
- Do wanna open up conversation, there was a portion that I took out and I want to hear your thoughts about it
- Yes there are black spaces in UCSB: RCOs, clubs, BCUs, offices
- Those more are black spaces that are community spaces that are catering towards each other
- But black empowerment task force is a space focusing on the betterment of the black community
- Yes it will be a space to be safe
- Sole purpose is towards making systemic change for following years
- Question that I would like to ask senators
- Originally it was senators as chair and vice chair but I took out the 3 additional senators
- I did this bc I am the only black senator and I wanted this to be a majority black space
- I didn't know which senators were gonna be passionate about this
- If any senators, more than one, is passionate about this, let me know

#### Brinderson

- Saw that
- You have honoraria of 1200, with 4 ppl splitting it
- You're just gonna split it between you four, 300 each?

#### Butler

- Yes it would be 400 each
- All of the other seats get honoraria, the others don't get honoraria
- Just for fall, will have to come back to make adjustments so they get paid throughout the year

#### Pinto

- So this fiscal impact is quarterly?

#### Butler

- Yes, as of right now

#### Pinto

So we need to amend that, would someone like to motion?

# Pinto

- So since this has an fiscal impact of over 300 a year we have to table it until finance committee can give their recommendation
- Legally means we can't pass it as of right now

#### Zha

- I have just been texted about exception of the legal code, which I'll send in chat
- Under pg 138 of legal code

- Basically says everything that's related to procurement above \$3,000 has to be tabled to FnB for their recommendation
- Apolgoize for confusion, but it's not related to resolution
- Fine because it's not about that
- We can pass the black empowerment committee resolution
- When we come back to MIP it will become a probleim
- Procurement relates to anytime you purchase anything
- I apologize for confusion

#### Pinto

- Since we have FnB chair here, Singh maybe you give recommendations

#### Zha

- Sorry for confusion
- Black empowerment we can pass there's no problem with that
- But when we come back to the MIP system, it will become a problem

# Singh

- That was it, not procurement
- But MIP system does need to be passed through FnB

# Siddiqui

- Important to remember procurement isn't just a financial impact
- Procurement specifically pertains to ability of someone to make their own independent purchases
- For example if we were to look at a campus department
- Procurement mainly pertains to the individual ability to purchase something

# ■ A Bill To Amend the GPA Requirement for Receiving Honoraria Butler - Siddiqui

#### Butler

- Try to keep it short
- Multiple ppl came to me to address
- Ppl have different ideas of honoraria, I think honoraria's very important
- Lots of ppl rely on honararia
- Last year, honoraria, which was money that I relied on, it was the most tumultuous process
- Took very long, lost of barriers, lost of ppl I had to talk to
- I think taking out the GPA requirement is a step in the right direction
- I know it goes through office of registrar which is why it's so tedious

- Lastly, I do consider yes being senate is a service position we chose to be in but
- I'm working here and I consider this position a job, I dont think our disbursement and process of getting students the money they deserve is adequate

# Siddiqui

- This legislation would vastly improve the speed at which the association established honoraria
- Anything we can do to make sure ppl are paid for the work they do

#### Lala

- Really appreciate this effort to make this process more efficient
- Have you guys checked whether there's something in university policy that makes this impossible?

# Holly

- A workaround would be, instead of saying maintain at least a 2.0, you could say ensure that the person receiving honoraria fits the requirements for being a member
- So it's not as specific

- If the by laws state that the eligibility for honoraria is in alignment with the requirements for membership, would actually mean that we could continue to check GPOA
- doesnt mean it can't be changed
- Would require a petition from student body at large or consitutional bill essentially
- If your intention is to remove the GPA requirement, don't know if referring back to the membership requirements would meet that goal
