Siddiqui

- One that's a little more complex
- First part is that there's section of legal code dealing with reserves
- Think it's article V of by laws
- Which is dealing with budget, might be article IV
- Essentially this new definition that we came up with
- This department is heading in the new direction of becoming fully integrated with student affairs
- Just across all different aspects of our division
- I thought it made sense to have this checks and balances
- To maintain structure of what we are as association
- Being student run but also having more connections with all departments in student affairs
- Getting better resources and advising from administration
- The definition I used here I ran it by all the VCSA's senior leadership
- Haven't gotten any pushback on this specific language
- I want to table this as well
- With the changes to policy 18, it's trying to target how we do personnel decisions
- When it comes to appointments and terminations there's already guarantees in legal code for student involvement and participation
- Problem we have is when we have a vacancy
- Even if senate directed a search committee
- On the day of search committee, things will be canceled
- That needs to stop
- We need appropriate amount of staff
- Needs to be collab with students and staff
- Consulted AS pro staff on this
- Had a meeting with Lily, had an HR 101

- She helped me draft this legislation as well
- Ran by the office
- Think the base of the legislation is good as is
- It's compliant with policy
- Eliminates a lot of the gaps in our current structure

- With an over \$ 18 million budget
- We're here, entrusted by students, to this unique position
- To ensure student involvement in operation of Associated Students

- Our job is to structuralize an already existing process

Can I bring up student sponsor?

Pinto

- Yes

Student Sponsor

- Hello again
- Senator Iden and I spent time trying to get the language right
- At least what we believe is right for these resolutions
- Important to get language right
- Especially for this to set a precedent for future referendums
- Think this is something that should be used more often
- Useful to pull student body
- Doesn't happen often in AS
- We don't believe cost should be included in referendum
- So as to avoid misleading students
- Projects can go over budget very quickly
- Can go under budget easily for many reasons

- Project hasn't taken shape, not appropriate to include price
- After senator Iden's discusisons with finance and budget, Michael Cea
- Been confirmed that without lock in fee, Michael doesn't believe AS has current ability to fund
- Obviously implications are that without passing this it would be impossible for a project to take place without a future lock in fee
- Referendum aren't utilized enough
- We believe the best way for the student body to understand this is a referendum
- That being said, would like to introduce more referendum in spring quarter
- Week 2 of spring quarter which is when the deadline for ballot is
- That can cover variety of issues
- Voting distributions on these referendum could give weight to which projects senators should work on next quarter
- Thank you and I'll defer questions to Senator Iden and proxy

Iden

- Jumping off of that
- In the coming weeks we are planning of introducing more referendums about properties in IV
- Alternative spaces we could provide students with
- Recording, art studios
- This referendum is super non binding, probably silly at the surface
- Would like everyone to give this their consideration
- The issue with tabling and getting results that way is that
- It's like subjective to bias
- When we're able to pull student body, ideally
- 20% is much more accurate and reflective
- Harder to see if people aren't interested
- Looking forward to any feedback anyone might have
- Super non binding
- Project like this wouldn't be possible if it doesn't go back to the student body
- Idea is get a handful of these referendum out, not just space issues
- Issues they like AS to work towards such as housing, pilot programs
- Getting that on ballot, using that as basis for senate to see
- Understand which projects are more permanent and which can be out towards the back

Zha

- Before I share my opinion of bill, I was in audience last week
- One question asked, which I'll ask right now is that
- Why should we get a billiard hall if students are facing a housing crisis?

Iden

- Totally valid question
- That's a question applicable for any questions for senate

- You can have your fun projects and more important projects
- Doesn mean you can't do the more basic needs projects
- If you look at most of our projects, we can ask why we work towards them
- It's a lot more all encompassing, work that we do in senate
- Obviously that's super important but there should be time for student led initiatives
- Not saying we're going to do it, just want to gauge student interest

Elkhatib

- I heard the student sponsor say that providing an estimate would be misleading
- Providing estimate would be misleading student body
- I disagree, think not providing estimate is more misleading
- New edits you didn't include that it would be most likely a lock in fee
- That would help pay for this
- Think that's an error
- Honestly I resent the fact that this is what is being brought to the table, it's not priority
- Don't think it's priority
- Also the average UCSB student doesnt know ins and outs of AS
- They wont know
- They're going to be like hell yeah, won't guess it's their fees going towards it
- I really think at least provide a range of possible budget it migt take and that it most likely will cause an increase in student fees

AG Carlson

- The non binding nature of resolution means that there will be no immediate financial impact for
- The financial impact is subject to affirmation of student body once that budget is well known, flushed out, and available
- Same students would be unaware would get to see do you vote yes on 3.5
- They would literally get to see, do you vote yes on this amount
- And here is project proposal link below
- This is more survey style questions with non binding
- With non binding financial impacts
- My understanding is that rent in any place is between 150-200k a year
- Is between 150 and 250k a year
- For something that could occupy a billiards hall
- We do this for example with pardall center
- We don't have an active estimate on how much it would be long term
- And that's where learning what those things would be
- In a year's worth of research
- After taking consideration of maintenance, staff, rent
- All of those are relatively unknowns
- Because we're not ready to go in right now
- Rent increases 2.5 to 3 percent a year

- Don't know what rent is going to be until we have lease agreement in front of us
- We don't know how much a staff member would be
- Understanding that bigger picture things will
- Will let us come back to senate with a proposal
- To show us financial impact that we can make good on
- Initial way to gage interest, much better
- Much better done in form of referendum, so students can
- Start dreaming about what is possible rather than saying no
- Because were simply unaware of what lies before us
- Take the first step and everything will become clearer in a year

Khorsandi

- I think we should use referendum as a survey
- Only a survey
- If they want billiards hall or bowling alley
- If it's yes, then we can
- But if they say no, no point in doing all of that
- Just testing the waters
- I see this as more of a survey

Singh

- What is the point to gage interest if you arent providing all the information?
- Yeah I understand you don't have exact estimate of what it might cost
- Take the pardall center
- The billiards hall isn't going to be much bigger than pardall center
- Most buildings arent big
- Put the estimate for that in
- Makes so much more sense
- A couple weeks ago, Nexus had post on instagram about resolution
- About a resolution we passed a couple weeks ago about exploring possibility for football team
- It was to explore possibility of having football team to UCSB
- Not even an actual team, just idea of having a team
- The response was brutal
- We had people saying "associated students really putting what matters first"
- We had people commenting laughing emojis
- We had the official UCSB women's rugby team comment on it
- We had comments about swim team still not having a pool
- Bowling is cool, when we all went bowling, I trashed all of them
- If that football posts tell us anything, is that students want us to fix what is broken first
- If we put this on ballot right now, without even knowing if there's interest, we risk looking like a bunch of idiots
- Without even considering real problems

- What has the Senate even done to adress day to day problems the student body faces
- One thing I'm working on right now is rent support program
- It's been stated multiple times, no one has contacted me to help me except the outreach
- Except outreach committee
- It's clear innovation is welcome
- There's strong desire
- Not saying it wouldn't be beneficial
- We have to understand timing and ideas of these manners just as much
- It's apparent that we should introduce new facilities, activities, but also
- Show it's in line of what students want
- If we keep throwing ideas that do not fix daily issues makes us seem out of touch
- Makes it seem like we're out of touch
- Best way, show
- Show some actual initial interest in it
- Have outreach committee do surveys
- Do an online survey, gift card we do usually, makes so much more sense
- More sense than us just making a statement
- We need to think hard about what we put into the ballot
- That ballot is indicative of what we think
- If we put on the ballot if they want a bowling alley, when half of our students are hungry
- Well most of our students have housing crisises
- What do you think they're going to think of us?

- Want to make it clear
- We're not here to speculate
- We are not here to speculate ecah other's intentions, or abilities
- Clearly approached from reason, from the student sponsor that's here with us
- I just ask that we remain cordial as possible and try to add in our opinions without coming for each other's opinions

- Yes. Just letting you know all our debate time for standing policy is 30 minutes, we only have 10 more minutes with this piece of legislation.

Zha

- I've been through 3 senates so far. Every year we talk about homelessness issues and hunger issues. At the end of the day, it's out of our hands and in the states countys, and regions. We can, of course, advocate but it's nothing we can control. But small things, small things such as an income package, those are the things we can control. Those are the things we can ultimately make happen.

- My point is that just asking students a question "do you want this or not?", you will not diminish the basic need issues they face every single day. All it does is do something students like. Take the extension of the recreation center, it's up to the students to vote or not. It's not up to us. Your term, and our term is about to finish, a question we have to ask ourselves is "what have I done for students?" I yield.

Pinto

- Any further comments?

Iden

- I'd like to put this to a vote because I'm not sure how much more discussion we can have. To respond to resolutions regarding the football team, if we approach legislation like this, and we're worried about whether it's the correct issue to focus on or if it's the right thing, you lose the potential of learning. We learn through failure.
- In terms of football discussion, I had no idea that the swimming teams' pool needed renovation and the rugby team needed funding. I learned so much. It directs us to other issues we should be focusing on. In terms of pursuing things like this, it's the best way to engage the student body and increase dialogue on these issues. Maybe they do want it, maybe they don't, we don't know. At the end of the day, just having the dialogue around these issues and the potential services we could provide, does not diminish the work we already do or the potential of the work we could be doing. I don't think it's the right approach to say no to this referendum because it's a great way to engage the student body in what we are doing and what we could potentially learn. Looking at Davis, when they were talking about operating their own bus lines and coffeeshops, it's a pipe dream. But I don't think shutting this down because there is not enough information is a way to cut dialogue back. If we didn't pass the resolution on the football team, I would not have known about the rugby team or swim team needing to use the high school pool because theirs is out of service. I just think the potential for dialogue is there, and I'd like to pass these along with other referendums looking into other issues. And I'd appreciate everyone's support on that.

Singh

- I'm not saying we should not have this under ballot at all, I'm saying before we make the decision to say yes, we will look at it in a serious way, we should get some initial comments and eyes on this. Then, we will look into it in a serious way. We should get some initial comments and eyes on this. I don't want the same reaction with the football thing.
- We still have until week 2 to have referendums on the ballot. It's week 8 of winter quarter.
- The outreach community can send a survey right now with a giftcard and get 100 people to respond. That is enough time to get enough comments and yes's and no's. We still have time before we actually put this on the ballot. Thats all I'm saying
- Get some initial eyes on this and get some comments on it. See how people feel about it before we stand behind it as an association.

Malhis

- I just have some questions. Similar to that entire situation with the football thing, you were saying how it could be a good experience to learn from failure and if we put this out, their dialogue will show. We already have diologue on the football one so why don't we start there. In reference to the Billiard Hall, UCSB already has pool tables. Essentially, in every residence hall there is a pool table associated with study spaces, maybe just not for Manzanita or San Rafael. And Isla Vista has two that are associated with the Dublin Bar. Are the pool tables being used? I know for some people that are living off campus, they shouldn't access the Chi 5 or residence hall pool tables. But if you are in a bigger party with a friend in the residence hall, then why not? Maybe the need for a Billiard Hall would be a little less. For the bowling alley, there is one close to campus, only a couple miles away and accessible. I'm sure not every single time people are at the bowling alley all the lanes are being used up. There is still access to these points of entertainment.

Iden

- I think those are good points. In terms of the football one, I don't think that's the same issue that is reflective here. I go to Dublin frequently, and it's impossible to get the table because people throw quarters down, and it's hard to get tables in the dorms becuase people are always there. It's not that these services are not provided. It's the same concept with Davis and their Coffeeshops. The possibility to have a revenue generating business within the association that we can put resources to and subsidize, because also the bowling alley is expensive. It's about having alternative recreational spaces and gauging interest, not necessarily saying if we are doing it or not. My last point in regards to an outreach survey.
- In terms of statistics, statistical significance is important in what is most reflective of the population. There is no better way to poll the population than to get a 20% poll on students. I think this is the best way to gauge student interest. It's not binding and without financial obligation. It's only yes or no. It could just say, "Would you be associated with operating their own coffeeshops or bus lines, this and that." The possibilities are endless, and I don't think we should limit ourselves.

- The general purpose of the committee is to serve as outreach for the food bank with primary goal of increasing student engagement through distributing merch and collaborating with other clubs
- So far, this quarter we continue our efforts with outreach via tabling.
- Continue our valentines snack kit
- We've continued to be open to doing, taking on extra projects for the food bank, and that's just another thing that we do, is we help them use it by taking on extra projects where they don't have extra extra hands.
- Or an example of that is we're currently working with public wellness, where we'll be providing steps and in relation to that food bank building their workshop
- We also continue to reach out and hold meetings with the organizations and clubs on campus, such as to find how we can best support their agenda while also promoting the resources available.

- Our goal is to increase that, and how we're going to do so is by staying active in summer and making more of a master plan of how we can be more active and engage with more organizations that we've reached out to.
- What we found was that we're a lot more effective when we have a better overall agenda that we can stick to and follow
- What efforts have you made to increase outreach in the student body?
- Every tabling event we attend we distribute brochures with resources on how to get into contact with the food bank, what programs the food bank provides, what resources they have as well.
- If we are ever funding clubs we set aside time to promote food bank and answer questions an dmake sure students can engage with the food bank and answer questions

Food Bank

Gabriela Munoz(7:33)

- My name is Gabriela Munoz. I'm the Operations Coordinator at the food bank, which provides free produce, pantry staples and basic products to the diverse UCSB community.
- Our mission is to tackle food insecurity on campus, while continually raising awareness surrounding food security, sustainability and social justice
- We offer a safe, inclusive space for all students, as well as confidentiality and all
 of their services.
- The Food Bank currently sponsors and hosts programs including pantry distirbution, the seed bank, online order programs, meal voucher programs, the vending machine program, the Halal and kosher program, the snack station program, and just like special programs and pickups to provide free and nutritious food to the eligible students that campus
- So far, we've distributed over 68,000 pounds of food at over 13,000 new visits and registered over 900 food items
- Financially, we have spent \$56,074.15 on food, which accounts for 16.7% of our annual food budget and 63% of our affordable allocation.
- This is just food. We've had a few little snags with getting money from the financial operations team to our vendors. So unfortunately, we did get pause as few of our vendors
- So this is a little lower compared to the fall quarter. We've also spent money on student and career staff salary, general operating expenses, which includes rent,

- supplies and then average events. And we don't have the exact numbers on this readily available, but we can follow up with the financial ops team if needed.
- As far as increasing outreach to the general student body, this quarter we've made numerous efforts to increase outreach, including Nexus interviews to promote our new voucher program, social media, posts, followers informative events
- We promote events on the basic needs letter. We've had calperg table about meal swipe donations. We had a meal kit within this and an Instagram meal kit challenge to get clients to repost their meals and just come into the food bank for group swag.
- We had a pop up pantry this past week at the San Miguel lawn to outreach to first year students, and if we did actually provide a written description on any of these, I think that concludes everything that I prepared for our winter Report.

- I'm a fourth year social major, and I am the other chair of human rights board. Miller
 - So to kind of break down our report, we're going to go over what we've done in January, February, and then our plans for spring quarter.
 - So to at the beginning of the quarter, we were very excited to welcome three new members to our board. So we were happy to get our appointed HRV Vice Chair, Hero freedom, who joined our board and for the start of the month, we also welcomed Jenny to our International Student Liaison position. She was unable to come to the stage during the fall quarter due to injury, but we're happy that she'll be able to come back during winter quarter

- And then lastly, our original SRJ co-director, Kaylee, she resigned at the end of fall quarter, but we were able to appoint Anne Myer to the new position. S
- Anne's previous position was an SRJ just under General Board member, but now you have as co director

Adjangba

- So next I'm going to update you on our subcommittee, Pip
- They have their library plan update, which is basically reorganizing the supply of books to prepare for their book packing. That's they send those books to the incarcerated

Miller.

- And then for our second subcommittee, SRJ, the students reproductive justice, at the start of winter quarter, they had a bonding event with their board to get to know one another and just bond.
- Then they also started allocating funds towards restocking the menstrual products vending machines as well as general SRJ supplies.

Adjangba

- So in February, our international liaison Jenny led a successful Chinese New Year celebration outside of the library. She partnered up with the global gaucho commission and gave away dumplings. It's really cute.

Miller

- Ouriggest event, human rights week, this week
- So the publicity committee built 3 breaking news Human Rights Watch segments bring awareness to international human rights abuses, including the situation in South Sudan, US Immigration and Customs Enforcement raids, and the force eviction of tenants in the GRC

Adjangba

- Monday we had social media and advocacy event
- We paired up with MSC international and UCSB political science professor
- It was about social media and advocacy
- Today we did impact event partnered up with PMHC and SCORE for mindfulness

Miller

- We made vision boards focusing on advocacy movemenets
- Making sure students were able to come in and envision their gaols

Adjangba

- We had food during that event, and the turnout was actually pretty nice.
- Tomorrow we have our solidarity screening. There's a film showcase of the 2019 film, 1982 which is about the Israeli invasion of Lebanon.
- And on Friday, we have our power of women in politics event, which is Angela discussing a panel of election women groups as well as queer groups.

- It's basically a discussion. So if you can try to show up, I think you guys could contribute a lot

Miller

- So more on the financial side. So obviously the capacity, we've been really focusing on budget planning for the 2025 and 2026, school year.
- So we've been working with our treasurer to plan this budget, and we will be presenting during the budget hearings on Monday, March 3,
- We're looking to start increasing funding for various projects supporting fellow student organizations and entities going into the spring quarter to limit our potential rollovers.
- Currently, we spent roughly \$12,000 but this is also amidst a recent funding allocation that we've made.
- So currently we're kind of looking at more towards the 35,000 to 40,000 range.
- So obviously we're looking to increase our spending going into spring quarter to support other as entities, rocs and potential events that we want to support going toAnd then moving on mroe of financial side

Adjangba

- On February 6, PIP had an immigration awareness program in Collaboration with UCSB divest
- On february 9 PIP had their first packing day in collaboration with UCSB library

Miller

- Then for our students for the Reproductive Justice Subcommittee on February 5, they had a student health reproductive discussion.
- Hosting a discussion panel on the reproductive resources available to us these students.
- This is also led by two staff members from Student Health.
- So there's a pretty much discussion to bring awareness to what UCSB students have access to
- And then on February 24 So earlier this week, in a kind of partnership, alongside human rights week, they had an event called the politics of Trans and Queer bodies.
- So this was to promote anti trans policies, the history of queer identities and indigenous communities and their third gender and two spirit population.

Adjangba

- So currently, we're working on different promotions, including a Black History Month celebration, addressing the recent Trump executive orders and LGBTQ bus resources and the recent ICE raids and integration, right resources
- We just posted the Black History Month today so please check it out.

- We're also in collaboration with our board members for our potential tabling effort during UCS fees open house, and able to promote our board

Miller

- So our second biggest event is our annual festival of culture, which will be taking place during spring quarter.
- So a festival of culture event will be held during mid spring quarter to highlight the diversity of the body that makes up UCSB.
- This will include collaborating with public campus organizations and entities just to kind of celebrate the different cultures that truly make up UCSB students.
- We just want to promote that through different or supplying different foods, workshops and events for students who participate

Adjangba

- At the end of the year, hosting a celebration with our two subcommittees, SRJ and Pip, we'll be hosting the celebration event.

Miller

- So, as we said before, so we're currently in the middle of human rights week, so we just had the last two days.
- We have two more days, tomorrow and Friday
- . So tomorrow's event will be showcasing a screening of the 2019 film titled 1982 which showcased the view of war through the eyes of the child, specifically highlighting the 1982 invasion of Lebanon.

Adjangba

- Friday's event will showcase women's work in politics with presenters from various women led organizations and professionals in the field,

Miller

- And then so obviously, as we go near the end of our terms as co-chair of the Human Rights board, as well as our undergraduate experience here at UCSB, we are focusing our attention on creating a legacy for HRV going into spring quarter.
- So our board continues to be one of the most unique AS entities on campus to highlight the pressing international situations of human right abuses, as well as celebrating the diverse backgrounds and identities and opinions of the UCSB Student Body
- We hope that next quarter you all will attend our festival culture and any events hosted by our pages for individuals in prison and our students for reproductive justice, SRJ, subcommittees

Proposed Article V Constitutional Amendments

Iden

- Just wanted to get this discussion started now so we don't do what happened last time. Next week, based on how this discussion goes, I have an idea of how I want to start this. Basically placing in the constitution, the procedures for rollover,

- I had some discussion with Michael, the Attorney General, and Senator Lala. We have discussed it for a couple months now. I'm kind of at the point where we need to do it and stop discussing it. I wanted to get people's feedback on the most proper way to do this.
- One of the options is how GSA does it, which is across the board unless there is an exception. They take 90% of the rollover and leave 10% in each of their organizations, so we could codify that.
- If there is excessive rollover, there is a possibility to pause their lock in fee for the year, and then let them spend their budget. There are endless ways to do it. If anyone has any ideas, I would love to hear it.

Singh

- I don't super agree with slashing 90% of the rollover. I think the big fuss about last was that BCU's were not involved in conversations about the rollover.
- I was suggesting if the rollover amount is over a specific amount, we ask them if they have a detailed plan over how to spend that money over the next 2 years, and then we decide as a senate entirety if they get the rollover. I don't think an automatic decrease in rollover funds is the right way to do it.

Siddiqui

- I think the intention is to set a general standard of how much we cut from most units. Certain units like ASPB need more because they store equipment and other stuff.
- I think it's good to go into budget hearings with this philosophy in mind, that way we can consult BCUs and talk with them from now on. Like MingJun has been doing during the reports, we can build on that at the budget hearings. I think it's good to have a preliminary idea of our goals before hearings.

Zha

- I'm not sure a constitutional amendment by itself would be enough to take out a lock in fee for general assignment. Each single lock in fee will be rotated by students and by Associated Students to use as money in specific lock in language. Second, eventually each BCU will have to be reviewed on a case by case basis.
- From a philosophical point of view, if a BCU has less than 50% of their annual budget, then the excess amount should be strongly considered for general assignment. As a student, the reason I pay the lock in fee is because I want the money this year, not for them to start up with students after I graduate. That's just my two cents.

Pinto

- Lets say an organization has been building a center or a project that takes multiple years. Would you be against putting money in that?

Zha

- I do agree Associated Students need long term investments. However, the reserve account of each BCU is not the place to start that money. For instance, the bike shop was not built by taking the lock in fee, but by taking a loan from Associated Students, increasing the lock in fee, and paying Associated Students back. We have the Associated Student reserve with around \$10 million dollars. So I just

think there should be lots of investment and money should not stay in BCU's account, but they should be in general Associated Student Reserve Accounts

Marissa

I encourage you to think about the language you are using. Your language is how do we take their money, cut their money, how do we do this? I encourage you to think about the affirmative side of that argument. What is the positive way to approach a BCU to say here's our end goal, here's what we are trying to get to, here's where we need your help. What is the ultimate goal? What are you going to do with that money? If I am a BCU hearing you say this, it sounds like you are just trying to take my money. If you come and say we have 90% of our groups that don't have lock-in fees, where is their money, and then you would give them the information they need to come to the logical conclusion they are trying to get to. Approaching them with the concept that "I'm trying to take your rollover" will cause pushback. I encourage you to think about what is a better way to help them get to the same conclusion that you are at, which is, what is the goal and our values as an organization? What is the purpose of this fund? How do we get to this together?

Iden

- I appreciate everyone's feedback and I think that's a good point. Those are good questions that I am still trying to figure out how to solve. One is what constitutes when we rollover? When are there exceptions? The other is how is the funding going to be utilized? Is this going to be in reserves? This solves the issue of how the association runs the deficit, by doing this, we will be able to fund BCUS's that are not funded by lock ins. The other one is what is the end goal? The end goal is lean spending and spending the entire budget. Ultimately the ideal world is we don't have to take anyone's money and they spend their whole budget the entire year. And I think this is kind of like the punitive step towards that. I know you're not a fan of the punitive measures but in a way, that's what it is. We need to advocate for spending their whole budget because we also don't want a scenario like last year where IVTU was going to buy Pardall Center out of nowhere. I am going to try and make a running document by Saturday to share with everyone who wants to give ideas or has opinions.

Pinto

- Are we having Senate next week?

Siddiqui

- Yes.
- Also I just want to say I think this time it will be easier because we have it outlined in our bylaws. This time it is going to be an MOU that's signed between the BCU and the Finance Committee.
- MOU
- I think the current structure of this is great that the group gets to approve off on things. I think the current structure of it is great, where the group also gets to approve off on things, determining whether it meets their mission statement or not. I think because we're operating under that framework, we'll have a much

easier time than last year. We're kind of lucky in that regard, because last year is like when they were starting, and that's much harder than just kind of carrying on the wave. When it comes to optics, our internal role is cutting rollover to redsitribute it and use it for student services. It's not like we are taking the rollover and pocketing it or putting it in unallocated. We are just tyring to redistribute it.

Marissa

 People on Slack already whisper about things like "oh here we go again" and "oh they just asked for BCU input 5 hours before the meeting starts." You're already off on a bad foot.

Siddiqui

- Yeah and I think the way it comes across from the BCU perspective, as a chair, is that no one looks into the expense reports and no one understands what the expense accounts are. Especially if you are a chair. Optics are really important in terms of making it clear what our motivations are from the get go to redistribute the funds. It's just another reason, going back to what Marissa was talking about, I have been critical of doing retreats in the past. It's not bad to do retreats, but we have to be careful about the optics about that in a public session. It's never malicious and usually with a joking intent, but we are in a policy position and we control students' lives in a department that is the second biggest on campus so it's a big responsibility.

Brinderson

- How will honoraria be docked depending on meetings attended?

Pinto

- It will be docked for spring if you don't show up

Brinderson

- Will it be proportional to how much you miss or are they going to cut all of it?

Pinto

- We were thinking, if you don't show up for 50% it will be \$50 deductions. This is a big part of our position.
