A Resolution for a Free and Fair Election Iden- Khorsandi

Iden (7:53PM)

- This comes after what happened last meeting, it was kind of heavy due to the debate
- The whereas clause just going to go through my intention with this
- As the senate, we're tasked with writing policy for AS
- We are meant to be fair governance and impartial leaders
- Tasked with representing the entire undergraduate
- Not trying to utilize our positions for personal advantage
- Recusal of conflict of interest is very important
- Normal to recuse yourselves for personal gains of yourself or associates
- It happens a lot in business, you can't vote in your own salary in many board meetings
- Abstaining from voting on election matters while actively campaigning for elected office helps uphold legitimacy and integrity of the election and senate
- Obviously we are an adaptive body
- Must continuously change the way we do our policies and how we vote
- These things are constantly changing
- By adapting to these new changes, we're upholding to standards to transparency, accountability, fairness
- In this election where there are multiple candidates that are sitting in the 75th senate
- And a clear conflict of interest has arisen
- Where individuals are participating in votes that are directly impacting the administrative roles and fairness of the election
- April 9th meeting, the senate denied a candidate from entering
- Traditionally an impartial body responsible for handling such decisions
- In the same meeting, we were open to extend other election deadline
- For impartial views it is a double standard in my eyes
- Double standard in my eyes

- Undermining our accountability
- We have to make sure we are taking a step back
- Candidates shouldn't be voting on candidate-related matters in this meeting
- By doing so we can help hold the legitimacy of the election
- Any member who is a candidate not only in this room or BCU, they have to abstain from voting
- They have to abstain from voting or make decisions regarding election rules, procedures, voting
- Anyone in violation will be reviewed by JC and elections board
- Discussions regarding elections, candidates who have declared must disclose their candidacy prior
- They have to be noted in the minutes
- If we are talking about senate elections you have to stay
- Say 'I'm running for senate'
- Any other decisions regarding election are deferred to elections board, ballot changes, eligibility
- It shouldn't be coming to the senate before the body that will be handling it
- Not necessarily appropriate that we were the ones handling it
- This resolution is gonna remain effective towards end of the year
- Should be standard practice that if you are running you shouldn't be voting in elections
- Want us to be as impartial as possible
- Want us to uphold our democratic integrity

Gerson

- Just gonna say thank you for bringing this forward
- I think it is something that is needed and will do a lot of good in the future

Malhis

- Agree as well
- Feel like this year we had a lack of candidates
- If we had in precedent that we allowed people to
- Should be a right of let another person participate for writing in candidacy
- That's the only fair way to do it

Brinderson

- Thank you for this piece of legislation
- Disagreement of last meeting was we didnt know what constituted and what impartiality really meant
- And how that was supposed to be implemented
- I'm not running, but I'm friends with people who are running, does that mean I shouldn't vote?
- More obvious and make sure that there's less controversy regarding this sorts of things in the future

Lala

- Author and I did not see eye to eye last week but that was primarily because it seemed to me like his argument was if you don't vote this way it's not proper and legal
- If you vote this way, this is proper and illegal
- This is entirely different
- What's being requested by this is entirely reasonable
- There's precedent for democratic and financial institutions as well
- I'm in sport
- Just wondering whether it covers all the points
- Brinderson brings up point that there are often candidates that are going to be involved
- Would you be open to opening theirs and looking into that or keeping it constrained to this
- Opening the resolution and looking into that or should we just keep it in simple
- There might be some wiggle room
- To give them some leeway

- With our legal code, that is covered under policy 15,

- That, even if you dont want it to, builds conflict of interest

Vote we had last time was above the threshold. The candidates that were running voted. This is a matter where any executive will receive 10k in financial gain a year. I find it proper to change the vote again with the proper conflict of interest excused.

Iden

- Regarding that motion, my intention behind putting that legislation on the board, because it's like not to exclude people from voting at all. I have nothing to do with senator Zha's motion.
- I still think that yes, they should be able to make that decision. They'd like to put it and really just want to make that clear,
- My intention was never to excluse people from voting at all

Brinderson

- I really felt like there was some sort of conspiracy going on there. So Thanks for clearing that up. And to this notion, I really don't I really don't like it. We're rehashing what we already did. And the idea was it was fair and it made sense. You passed the deadline that everyone had to follow. If you get to decide, oh, now I want to be a candidate. That's fine, but you have to be a writing candidate, because that's what's on the website.
- If you're going to talk to individuals, and you're getting a privileged position because you have this conversation that's fundamentally unfair, and that is democracy. You don't get to, like, go talk to administration. I do want to make this clear

Iden

- My view on this is the same as before. I'd like it for the election board to have that decision. I think everyone could agree that every student has the right to run for office. Everyone deserves a fair ground. When it comes to deadlines, yes, I agree with Senator Brinderson. At the same time do believe that every student has the right to run. I guess it's up to us to explore the potential of those deadlines. The way the system is right now is not exactly fair

Zha

- First, I want to clarify that Senator Iden was not working with me on that motion. I asked him if he'd be willing to second it, and he said no, which is completely fair. That motion was solely mine; I was not collaborating with him.
- Second, this motion will not create significant conflicts of interest within the Senate. It simply grants power and choice to the Elections Board, an independent agency tasked with making impartial decisions.
- I want to make this absolutely clear and put it on the record. I have saved a text from Siddiqui that I received this afternoon. In it, he sent me a list of ongoing investigations being conducted by the Office of the Attorney General.
- Here's the issue, the report outlines serious impropriety, including candidate suppression and election manipulation. The only reason Le Anh Metzger was allowed an exception was so she could meet the deadline, and she still missed it. That is unacceptable.
- I made this motion to give the Elections Board the opportunity to make it right to ensure fairness and integrity in our election process.

Kadah

- just want to echo his sentiments. I honestly don't understand why this is being brought back up. As was already mentioned, deadlines exist for a reason, people need them, and everyone has the choice to run, regardless of whether or not someone reaches out to them.
- Even in cases where there's talk of collusion or coordination, the decision to run is still ultimately made by the individual. That's their choice. So I don't understand why exceptions are being made for people who miss deadlines.

Gerson

- We're arguing about the wrong thing here. The focus has shifted to whether she missed the deadline and whether that was right or wrong, but that's not really the core issue.
- What we're actually discussing is whether the decision is ours to make or the Elections Board's. Some are saying we already made the decision, so we shouldn't rehash it, but that's exactly the point. We made a decision, and maybe it wasn't ours to make in the first place. What senator Zha was saying is that we just passed a resolution affirming our commitment to being impartial and unbiased.
- That's what this is about,upholding that principle. Even if bias occurred or something went wrong, we still have the opportunity to fix it. This is exactly what we should be doing,handing the decision over to a body that is designed to be neutral. The Elections Board exists for situations like this. They're better equipped to determine what happened, what's fair, and what's just. Instead of debating the details, we should focus on how we want to present ourselves to the student body. What we're opposing right now contradicts the values we just agreed to uphold.

Khorsandi

- As elected student body representatives, it is imperative that we reflect on our past actions and learn from them. I understand that we've already gone through this discussion, but revisiting and reassessing our decisions is important for our growth.
- I want to echo what Senator Gerson said, we're not making the executive decision here, and that's the whole point. Many of us, whether we like it or not, are influenced by personal interests to some degree, that's just a part of being human.
- But this motion is about giving the responsibility to a body that is meant to rise above that, one that is designed to be impartial and free from personal bias.
- As representatives, we have a duty to act in the best interest of the student body, not for ourselves.
- Even though we hashed this out last meeting, I believe it's valuable to revisit it, not to relive the debate, but to learn from it.
- We should reflect on what happened, consider how we can grow from the experience, and think about how it can help us become better individuals and better representatives.
- If we can share our perspectives and grow together from them, we'll be better equipped to serve the student body in the future. I hope everyone keeps that in mind as we make this decision today.

Kadah

- I don't necessarily fully disagree, some of what's being said feels a bit targeted. In these discussions, there's been a lot of alluding to people who are current candidates.
- Everyone has their own biases. But we, too, are supposed to function as an impartial body.

Iden

- Point of order
- You have to identify yourself in this discussion if you're running for candidacy.

Kadah

- I am running for EVPLA. I am not even saying this for myself, I am just thinking that other running candidates have been targeted. I think it is against the code to bring things up without any evidence as well.

Zha

- I appreciate the point that was raised. However, the only reason I'm bringing this up is because Siddiqui, through whatever means, acquired access to an internal investigation conducted by the Office of the Attorney General.
- I was involved as a cooperative witness. If that doesn't qualify as intimidation, I honestly don't know what does.
- I can speak to the legitimacy of those allegations, and it is my understanding that they are serious and deserving of our attention.

Butler

- In my interpretation, I think that was speculation

Zha

- I was not speculating the intention, but describing the action. I respect the ruling of the chair.

Gerson

- I didn't mean to offend or target anyone with what I said. We all just passed legislation acknowledging that there is bias in the Senate, especially given that some members are currently running for positions.
- That bias exists, whether consciously or unconsciously, and I'm not here to point fingers or say, "you're running for this, so you voted for that." That's not my goal, and it's not what I'm doing.
- We collectively recognized this issue, and maybe that means we need to take a step back and allow someone else, someone impartial to handle it.
- If we all agree that this bias is real and are willing to acknowledge it, then we should be asking ourselves, what's the fairest way to deal with the process? Not necessarily change the outcome or mess things up. Just deal with the process in the fairest and best way possible. I think what that means is turning it over to the election board. We're at a perfect opportunity to catch our mistakes and the year in which we want to be remembered.

Proxy Gundecha

- I'd like to adress a couple of things, firstly i'd like to say that when we are looking in and speaking about senators names

Point of order. Does he have to identify himsellf as proxy?

Butler

- If you are talking for senator Siddiqui, make it known. Then the rest of it, we'll know its coming from you

Zha

 Point of order. It is expected for proxy to only express wish of senator and not their own

Proxy Gundecha

- What if I'm simply speaking about events that actually happened
- I'm a proxy for Dan Siddiqui, who is running for president, and I want to clarify a few things.
- Throughout this discussion, a senator's name has been brought up repeatedly, yet in the vote that's being referenced, that senator actually abstained. He did so because he believed in fairness and didn't want to influence the outcome due to his position.

- There has been no contact whatsoever between him and the candidate in question.
- The issue I'm having here isn't necessarily that this situation is being brought up, it's that it's being framed in a way that implies connections and intentions that simply don't exist.

Amin

- The proxy just said the issue that "I am having". According to Robert's rule, he has to speak for Siddiqui and not for himself.

Butler

 You are supposed to be proxying. Proxying is not you but you are representing senator Siddiqui

Proxy Gundecha

- How would I refer to myself? We?

Butler

- If you are voting on a resolution for free fair election, it is not necessarily you, you are voting for Dan. It's Dan's vote through you

Amin

According to Robert's rules, proxies are not even allowed to speak during discussion

Suuck

- Just feel like we've been doing this for so long now. Let the man speak Butler

- Moving forward let's refrain from that and keep it in mind. Let's ground us

Idenn

- Point of order. Proxy Gundecha had the floor before

Proxy Gundecha

- Dan has lost his thought. Senator Siddiqi is having issues that he is being talked about in this manner currently. I would just like to express my gratitude to the rest of the senate who has been accomedating, I apologize for breaking rules of order
- This conversation has changed to an attack
- Dan believes this should be focused on unbiasedness of the body
- This conversation should be focused to the unbiasedness of the body

Butler

- This isn't a conversation about senator siddiqui
- We've been talking about this for 20 minutes

Zha

- One last point. I completely agree with what the proxy just said. I recognize that I, too, have personal biases about whether a candidate should be allowed on the ballot, and because of that, I should not be the one making that decision.
- None of us should. That's exactly why the Elections Board exists, as an independent body, established under proper guidance, to handle situations like this with fairness.
- All this motion does is formally grant the Elections Board the authority to make that decision alone

Elkhatib

- I hate this argument that if something involves bias, we shouldn't be allowed to vote on it. If that's the case, then why are we even here?
- By that logic, we shouldn't be voting on anything, everyone brings some level of bias to the table.
- This consideration was brought to us last week, and at that time, we reserved the right to vote on it, and we did.

Khorsandi

- First of all, I want to echo the fact that I think especially during elections, people think that there's targeting occurring. If senators believe that one specific senator is being targeted, then that is even more reason to defer to the Elections Board.
- It's not that people are necessarily targeting others, but the very idea that someone could be targeted is something that can be considered unfair and biased.
- Both sides should be able to agree that we should defer this to the Elections Board. Also, this is different than voting on just anything, this affects monetary compensation. Ten thousand dollars is a lot of money, and if there are senators who believe candidates are being targeted, that's even more reason to move this to the Elections Board.
- We aren't in the right place for any single one of us to make a fair decision on it, because there are just so many emotions, so many people involved, and so much at stake in the matter.

Gerson

- I didn't really understand what Siddiqui's proxy was trying to say. To the point that we're all biased and therefore shouldn't vote on anything, obviously, we're here for a reason. We want to vote on things we care about, and our bias and lived experiences naturally influence how we act as senators. But when we're talking about issues that affect individual positions and monetary compensation, serious things like that, it doesn't make sense to keep the decision within the Senate, and we already agreed on that.
- We all just voted that bias exists here and that we're all involved in some way. So I don't think we should be the ones to make this decision. Most of the Senate doesn't either, based on how we voted.

- What we're arguing about now is something we've already resolved, so maybe we should leave it there. Just take a second and think, if we hadn't already voted, how would you vote now, and why? How do you want to be remembered? How do you want to be portrayed? Maybe take a few seconds to reflect on that.

Butler

Would you like to amend your motion?

Zha

Yes I will amend to a hand vote

Neo Harter and Xander (7:36PM)

Neo Harter

- So Xander and I are both on behalf of adding a UCSB business major
- Asking you to look into is to add the wording into the referendum
- Hoping to present this to you so when you are voting you can have the presentation
- Address the feasibility of adding a business major to UCSB
- Give you guys a comprehensive understanding of what I was envisioning

- When you decide to vote, you are voting with a bit of confidence
- Our goal is to get UCSB to implement a business major in next 3-5 years
- Within the next 3-5 years, the actual implementation of the business major is a bit nuanced
- Doesn't necessarily have to be a complete business major
- Problem is that we offer econ and accounting
- We offer econ and accounting but it does not translate to the field we work
- Also a website that has the requirements and actual reality of job market when you arrive there
- The idea behind presenting both pieces of info is discrepancy
- Most common fields are much more hands on than economics
- Econ department is oversaturated as well
- What I wanted to show is what an actual business major looks like
- This is the business program for UC Berkeley, group of courses that UCSB does not offer
- Those specifically are a group of courses that UCSB does not offer
- When I say we need to add a business major,
- That's kind of intense wording
- Just add a group of courses that adequately prepare students that adequately prepares students about what they're going into
- Chair of econ department Kelly Bedard here addressed the necessity behind business major, students at UCSB need to be prepared for future in business
- Didn't agree with what I'm saying
- Which is what I'm saying the econ department doesn't do it well
- To prove her wrong I have the actual business sheet here
- You can see a clear discrepancy of
- If you compare the sheet
- Discrepancy in what econ major offers and what a business major needs
- The discrepancy proves her wrong
- The solution is we don't necessarily need to add a huge department, the econ department has many courses that would coincide, just not good enough yet
- What we need to do is just add professors, new courses, potentially
- Once econ degree is brought up to speed, maybe we can just advertise the major to include a business component
- Identifying the gaps and comparing the UCSB to the Berkeley business school
- Figured, UCSB and Berkeley were best analogous
- Step 2, hire professors
- Begin class structural progress
- Step 3, change name of econ major
- Begin to advertise the new and improved mahor

In terms of inflation and production costs, this change is not going to last two years. I would rather fund it partially and then look at longer term solutions where they can get this funding because they are also going for a lock-in fee increase in this election by 50%.

Zha

- Two points. First, this will not fundamentally address the meal problem on campus, but I think improvement does not mean it is not worth our consideration. I do believe it is a good plan and worthy of our execution.
- Second, we asked the food bank if the increased lock-in fee can be paid and their response is that they already budgeted the increased amount.

- The lock-in increase has nothing to do with this. The lock in fee increase, if they get it, they have way different purposes that the senate initally wanted, but they already have a plan for. If they already have plans put into motion to acquire the things they want to acquire through their fee increase, why would the senate instruct them to do something just as impactful? Senator Iden, I need to catch your drift dude and I'm not. The senate wanted them to get fridges, they have plans for it. They already have plans for warm meals, they have plans for berries. They have plans that are none of our business. They are the food bank. If they are the most funded BCU, it's for a reason. There is no one here who has not used the food bank. It's not only the most impactful BCU. It's. It's also one of the most public places. It's one of the most used BCUs. You can always put a sign in front of the food stations saying that they are funded by your student fees from Associated Students. I agree that the way the economy is going, this is not going to last the next 2 years, but that is not a reason. If we do what you are proposing, it is up to next year's senate to give them the money or not and I can't tell you what next year's senate will do. This is a conversation that has lasted 2 quarters. - I am the Founder and President of the Armenian Pre-Law Society, and the Vice President of the Armenian Student Association, I stand here today alongside many Armenian students, not just to represent ourselves, but to represent every marginalized identity that has faced systemic injustice and oppression throughout history.
- Today marks the commemoration of the Armenian Genocide, a tragedy that remains a forgotten chapter in history for many. Decades of denial and silence have allowed manufactured narratives and widespread ignorance to persist, ignorance that has been instilled by governments, universities, and societies alike.
- I could stand here and deliver a thorough history of the genocide. But my goal today is not to condemn any group of people. I am here to take a stand for truth and remembrance, and to speak out against the ongoing silencing of Armenian voices. Despite the systematic attempts at denial and erasure, Armenians have persevered. We have restored, rebuilt, and maintained our identity.
- That resilience is why we are here today as UCSB students, to reject cycles of denial and ignorance, and to strive for a campus culture rooted in justice and awareness. The first step toward that goal is recognizing April 24 as Armenian Genocide Remembrance Day. This initiative is vital. UCLA, UC Irvine, and UC Berkeley have already taken this step, and it's time we do the same.
- Recognizing April 24 and designating April as Armenian Heritage Month will not only honor Armenian lives and history, but also educate future generations. It is a symbolic commitment to all marginalized communities, a statement that their histories will be seen, heard, and remembered.
- This designation will allow for the celebration of Armenian culture and heritage, for the sharing of rich traditions, stories, and voices. It affirms that this university welcomes all of us, and that we each have a space of belonging on this campus. It identifies and affirms the truth of our roots.

- Therefore, tonight, I ask each and every one of you to take part in making history at UCSB. Let us affirm that this university stands on the side of true justice and remembrance. Stand with us, not only in memory of the 1.5 million Armenians who suffered annihilation, but also in honor of the generations who carry their voices forward.
- By implementing this proposed legislation, we will take a powerful step toward healing wounds that remain open 110 years later. We are here today because of the resilience of our ancestors, forces that tried to erase us and silence our voices. We are living proof of survival, and our continued presence depends on individuals like all of you to give us the tools to amplify our voices.
- UCSB has a choice, to turn a blind eye or to become a university that champions inclusivity, remembrance, and truth. Thank you for your time and compassion.

Jenny Stepanyan

- The Armenian Genocide was a brutal and deliberate campaign carried out by the Ottoman Empire from 1915 to 1923. It led to the deaths of 1.5 million Armenians, as well as countless Greeks, Assyrians, Kurds, members of the LGBTQ+ community, and others.
- The Armenian population was subjected to unimaginable violence, men were executed, while women and children were forced into death marches through the desert. This was not a byproduct of war, it was a calculated attempt to erase an entire people.
- The cruelty of the genocide even inspired Adolf Hitler, who justified his own atrocities by saying, "Who, after all, speaks today of the annihilation of the Armenians?" This chilling quote underscores not only the global impact of the genocide but also the devastating consequences of silence and denial that followed.
- In recent years, there have been efforts to break that silence. In 2021, President Biden became the first U.S. president to officially recognize the Armenian Genocide, stating that "the American people honor all those Armenians who perished in the genocide." This acknowledgment marked a critical moment in the broader movement for human rights and justice.
- As was mentioned earlier, many university campuses have taken steps to recognize and honor this history. Institutions such as UCLA, UC Irvine, USC, and UC Berkeley have hosted commemorative events, educational discussions, and remembrance ceremonies. However, there remains an absence of recognition at an institutional level here at UCSB.
- Given the actions taken by our sister campuses within the UC system, it is imperative that UCSB also take this step. Recognizing the Armenian Genocide would not only honor the memory of its victims but also reaffirm UCSB's

commitment to justice, remembrance, and the support of all marginalized communities.

Khorsandi

- Thank you for coming to speak, for educating us, and for sharing your perspective. I'm Jewish, and my ancestors also experienced genocide, so Holocaust Remembrance Day is important me.
- I totally see why you want to have a day of recognition.
- Have you spoken to the administration or any school officials about this? And have you received any response or support from UCSB so far?

Lily

- The only people that I've contacted were you guys in the previous years. I did send a letter to Chancellor Yang and his entire office, and I have received no answer

Jenny

- There has been other articles published saying that they've also written to Yang and haven't gotten an answer or pushback

Brinderson

- Thank you for coming and bringing such a strong and unified voice with you. The Armenian Genocide happened, it was horrific, and it inspired further acts of genocide. When we remember genocides, it's essential that we remember every single one. We can't s forget or choose which histories to honor.
- I'm not fully sure what capacity we as a Senate have to act on this But I really appreciate your initiative, and I agree with what you're asking for.
- Getting this in front of the administration is a crucial step, even though we all know they're often not very responsive, that's unfortunately just how they tend to operate.
- One thing that came up in our last meeting was the mention that a similar request was made last year.
- When that happened, members of the Turkish Student Association showed up and had very specific concerns and demands. From what you've shared tonight, your request seems incredibly reasonable, you've made no attempt to blame students or entire governments. That said, I do want to ask, have you had any interaction or communication with the Turkish Student Association so far?

Lily

- Not really, we haven't had direct interaction with the Turkish Student Association. Of course, there's always going to be backlash, and we expected that. That's exactly why we made it a priority this year to bring out everyone in our association and amplify our voices, to ensure that they wouldn't be silenced by

others. We've also been very intentional in our approach. We are not condemning or putting down any group of people or any nation. Our number one priority is simply to have April recognized as Armenian Heritage Month, and April 24 as Armenian Genocide Remembrance Day. We're just trying to honor our community and our voices on this campus, without interfering with or antagonizing any other group, because we know that would only lead to chaos

- Our polluters page view will be voted on next session, moving to floor where it's gonna be voted on

- They all come together and make up this council
- Basically 1971, when Reagan was president,
- They determined that they were unable to handle external affairs
- They delegated that responsibility to a UC student lobby, UCSA
- We are the employees recognized by UC system and state legislatures
- How we run is we have an external VP at each campus, SB's is monica
- There's a legislators director as well as organized director that sits on our board as voting members
- That leads to a large baord
- As well as we have appointed officers
- Thast a person who represents a specific topic
- Basic needs officer
- Campus climate, etc
- How our board is formed
- There's executive positions, I ran for president so I'm grateful for that
- 5 standing campaigns
- There's ACQUIRE which covers basic needs, healthcare, textbook affordability, everything

- SEED is our environmental justice and indigenous justice campaign
- Racial justice now is our racial justice campaign
- UCweVote civic engagement
- Fund the UC is our tuition affordability campaign
- Goals are voted on by students every year
- Conference in August, everyone comes together and vote on their goals that they want the association and board to work on
- This year, acquire, our campaign
- Alternative to Calfresh for specific undocumented and international students dont qualify for Calfresh
- Don't qualify under immigrant class in calfresh
- There's no room in that for state budget due to budget deficit
- There's also a limit of number of bills each state representative can introduce
- Due to those constraints, been navigating it by going on each campus

- Going on each campus and finding an insitutinal alternative
- UCweVote, focusing on voter efforts post-election
- There's been a lot of stress in students communities
- Before elections we were focused on increasing ballot boxes on each campus
- For SEED we are increasing direct access to chancellors for native students,
- By having native student advisors to chancellors
- Currently only 2 school staff student representatives on those native advisory boards
- Usually just a staff advisor, tyring to get student representation
- Our racial justice campaign is navigating free speech on campus
- Specifically, letting students know what their rights are
- Especially with the new enforcement policies that weren't passed, not enforced as broadly
- Fund the UC, we were endorsing a piecemeal approach to Calgrant equity
- It was a framework that passed
- Due to state budget deficit, it passed in the state 2 years ago
- But due to the lack of budget,
- Cal grant equity includes a framework which basically increases access to Calgrant for students who are less traditional
- That looks like allowing students to took a gap year, or who took more than 4 years
- Or who take more than the traditional 4 years to still have access to scholarships
- Due to the budget we are starting out with student advocacy first
- One of the components tackled in Calgrant equity framework
- How that's looked is introducing specific bills
- Some are student parent focused
- Working with state reps to see where we could get increased funding
- Apart from this, we have a bunch of policy priority
- Due to that appointed officer program I mentioned before
- They tackle specific projects for year long period
- Me as president, have my own priorities
- Free speech specifically I've been working with
- Working a lot with system wide admin to push back on policies that are very restrictive
- External vice president have been big on keeping contact with individual chancellor's regarding those free speech policies
- Ensuring that the time place manner restrictions follow precedent of stduents allowing students to speak
- Of actually being able to have students speak
- Some campuses have restrictions on where, what spaces
- What buildings you can speak in front of, we are pushing back there
- Done a lot of investigation into UC investments
- I've been in convos with UC investment, have a more clear understaiding on how system wide investing work

- As well as individual investing boards, only 4 compases that have an individual investing board
- Most schools fall under the system wide investing model
- Santa Barbara is one that falls under system wide
- A lot of advocacy has been seeing how we can utilize advocacy
- Currently there's zero student perspective
- No investments in private prisons
- None in tobacco
- None in fossil fuels
- Metrics are clearly defined by index funds
- They are the only ethics involvement discussion in our current investment
- And discussion in our current investment
- Really trying to increase that
- Weapons and war as parts of the ethic metrics
- Also are really prioritizing undocumented student advocacy, green card, partial residency, students who are at an increased risk
- Calling for condemnation of current administrative policies, and
- Investing highly in legal resources system wide
- There's system wide legal resources that exist for students
- None that clearly tailor to needs of international students or students with varying employment visas
- We are really trying to make sure that UC can contract lawyers that can help students in a pro bono way
- Where students aren't forced to bear the run of that financial burden
- Also to have that advertised widely to students
- A lot of students dont know if their visas have been revoked
- They are unable to get appointments with their international student representative
- Black student success is also one of our priorities
- Regarding increased advocacy for programs like UC prime
- Like UC prime, but expanding to pharmaceutical, dental, vet schools
- Helps retain a diverse range of students
- Helps them stay in med school and work back in their community
- As well as work back in their communities
- Expand it to other realms of schools
- On black student success, pushing back on any efforts that schools have taken to delve into any race neutral territory
- Police accountability is a huge emphasis
- Currently how they operate is that police accountability boards do have student representation,
- But the verdict that they come to is not enforceable
- Make a judgement based on what they have found
- Really pushing back to ensure students have power there with their findings
- Findings that they are able to find in the police

- People i have interacted with this year are so passionate and are doing amazing work
- Jumping back to Senator's Brinderson's point, I request that you don't vote on this Senator Zha
- I feel like I would feel more confident passing this bill if there was a maximum and it's up to the honoraria committee of whether or not to do it
- Because right now the maximum honoraria is not stated, which could lead to other conflicts internally like rewarding JC for certain verdicts or how they decide to operate
- It could lead to financial bias

- I will be excusing myself from the vote
- JC is very unique
- I can share a littl bit of my experience as someone who has been in JC for 3 years
- They have a lot of work and they are unpredictable
- We do not know when we have to do it and we have to plan our schedule right
- The nature of KC just doesnt allow things
- I appreciate Senator Iden's point of setting a maximum
- My only objection to that point is that JC's case varies very much
- For instance, JC's last case with the constitutional work, we spent hours and hours of work

- Hitting me that peg as a verb in the economic sense is usually to fix or keep something at a certain level.
- But also has the connotation, if I'm not mistaken, that when whatever you're rising one thing, the other thing you are controlling for also rises as well
- So sure it's probably not going to be appalling in the near future.
- But if at some point, Senator honoraria rises with this, also rise with it because of that language choice
- Second, unless it's explicitly forbidden elsewhere, I think that the latter option makes more sense that JC is that type of institution that needs the kind of independent wherever it can be granted, including in the way they are paid
- In my opinion, it's much less dangerous for them to be doing less work than we perceive.
- Then future elected representatives knows that at the end of the day, we control how much you get paid

- I want to say maybe there's a system that's designed to be qualitative in nature, in terms of certain cases taking less time and certain cases taking more time.
- So if we could add in some language about physical man hours, and potentially we could add thresholds of man hours that equate to certain levels of honoraria

- No part of the judiciary should go through bodies like ours
- I would be against adding hours in language because that can be misinterpreted in a payroll context
- Different form of financial context

- Yes
- By pegging the honoraria of judicial council to honoraria standing committee,
- There would not be a need to adjust the honoraria independently
- The reason it is written that way is for the independence of the judicial council
- You do not want a future senate to control honoraria

- Second, I think the danger in having senators in signing honorair to Judicial Council is how the current systen works

We are in the state street room because renovation on the room upstairs was supposed to start last week. It did not. It will be starting on May 1. So we're here for no reason and someone else got upstairs anyway. So apologies. It's only supposed to take 2 weeks for them to do all the work in the ceiling and everything. We talked about elections a little bit. We are still revising amendments and things getting feedback from UCOP who is still probably angry at us for the timeline we've given them for getting back at us. We talked about USSA. The UCSA president, who was here, mentioned advisory boards. I'd just like to really encourage folks to look for them, because they're very poor at advertising, so it's hard to know what exists. The PATH accountability met last week for a 'come see what's going on' and nobody showed up. If you are curious about things like police accountability, I encourage you to look out what is out there and google it because there are openings for undergraduates, grads, things like that. And even if they don't necessarily have the power, you still have nuch more of an insight into what is going on. One thing about bills, I wanted to bring this up last week. Remember that bills in particular, what is written in the bill matters, what is discussed here does not. So when you make a bill, be very specific, otherwise you are setting the future senate up to be angry at you. They can't go back and ask, 'what did they mean.'Like have you ever looked at the legal code and asked 'what does this mean,' yeah don't do that. 2005 people did that, don't do it. I don't write bills, but I'm just giving advice for people who do. I think Holly can share the image I sent. That is the Storkie mascot we will be getting very soon, very soon being like 8 weeks. I had another one that shows the person inside like the outline, but you basically look through the windows where the cell towers are. We purchased it, and put a deposit. It will be checked out in the same manner in

which we do photography. We will have designated mascots, not just any one can go in. So that was my list of updates.
